AGREEMENT FOR IRRIGATION EASEMENT AND DEFERRAL DEDICATION

I, Devon M. Glenn, Manager of The Boyer Company, L.C., the Manager of Boyer Project Company, L.C., the Manager of Boyer GSA Warehouse, L.C., (hereafter "Owner") of the hereinafter described real property in Marriott-Slaterville City (hereafter "City"), Weber County, Utah, grant unto Marriott-Slaterville City, Utah, a municipal corporation of the State of Utah, and any successors, a covenant to run and attach to the following described real property (hereafter "Subdivision" or "Property"):

ALL OF BOYER TWELFTH STREET SUBDIVISION

In consideration for Marriott-Slaterville City, a municipal corporation of the State of Utah, allowing the above Owner to improve and develop this property without dedicating to the City certain required improvements at this time, the Parties agree to:

- City agrees to defer dedication of the Subdivision secondary water system as provided herein.
- Owner agrees to dedicate the secondary water system for the Subdivision and all related water shares equal to the duty value specified by the State Engineer for Weber County, unless stated otherwise in the municipal code at the time of dedication, until a future date after request from City and as provided herein.
- 3. City agrees to defer all secondary water impact fees.
- 4. Owner hereby grants to City and Marriott Irrigation Company an easement within the "public utility easement" as indicated on the dedication plat for the Subdivision for the maintenance of irrigation ditches, head gates, irrigation pipelines, and other secondary water facilities.
- 5. Owner consents to annexation into the Pioneer Special Service District, including consenting to the creation of any related special improvement or special maintenance district relating to the deferred dedication, and said Owner agrees not to protest full participation in any such district.
- 6. In the event that the City requests dedication of the secondary water system, Owner agrees to dedicate said system within 90 days of the request of the City. Parties agree to agree upon all of the details of said dedication if such dedication is requested by the City in the future.
- 7. City agrees that so long as the Subdivision, including all Lots therein, remain under the Ownership of the Owner that City will not request dedication under this Agreement.
- 8. Owner consents to recording of this Agreement in the Office of County Recorder.
- 9. This Agreement serves to secure performance and run as a covenant on the Subdivision.
