**FIFTH AMENDMENT TO AMENDED AND RESTATED
DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS
FOR SCHNEITTER'S SWISS OAKS**

An Expandable Condominium Project

THIS FIFTH AMENDMENT is made and entered into as of the 12 day of NOVEMBER, 2002, by SCHNEITTER'S SWISS OAKS CONDOMINIUM OWNERS ASSOCIATION, a Utah Non-Profit Corporation.

RECITALS

A. The Declaration. There has been previously executed a Declaration of Covenants, Conditions, and Restrictions for Schneitter's Swiss Oaks, an Expandable Condominium Project (hereinafter referred to as the "Declaration"), dated September 24, 1985 and recorded September 26, 1985, Entry No. 136583, Book 175, Pages 418-482, at the Wasatch County Recorder's Office, submitting the Land and Buildings as described and defined therein to the provisions of the Utah Condominium Ownership Act (Title 57, Chapter 8, Utah Code Annotated).

B. Amendment and Restatement. The Declaration was amended in part and restated in its entirety by an Amended and Restated Declaration of Covenants, Conditions and Restrictions for Schneitter's Swiss Oaks, an expandable condominium project (hereinafter referred to as the "Restated Declaration"), dated July 2, 1990, and recorded July 27, 1990, Entry No. 152843, Book 220, Page 316, at the Wasatch County Recorder's Office.

C. First Amendment. The Restated Declaration was amended by a First Amendment to Amended and Restated Declaration, dated October 2, 1990, and recorded October 2, 1990, Entry No. 153528, Book 222, Page 337, at the Wasatch County Recorder's Office.

D. Second Amendment. The Restated Declaration was again amended by a Second Amendment to Amended and Restated Declaration, dated August 9, 1991, and

recorded August 9, 1991, Entry No. 156930, Book 232, Pages 197-207, at the Wasatch County Recorder's Office.

E. Third Amendment. The Restated Declaration was again amended by a Third Amendment to Amended and Restated Declaration, dated September 2, 1992, and recorded September 2, 1992, Entry No. 162057, Book 246, Pages 558-563, at the Wasatch County Recorder's Office.

F. Fourth Amendment. The Restated Declaration was again amended by a Fourth Amendment to Amended and Restated Declaration, dated September 8, 1993, and recorded September 14, 1993, Entry No. 168072, Book 264, Pages 588-594, at the Wasatch County Recorder's Office.

NOW, THEREFORE, the Restated Declaration is hereby amended and supplemented as follows:

1. Section 1.21 of the Restated Declaration shall be amended in its entirety to read as follows:

1.21. Unit shall mean an individual air space unit, consisting of enclosed rooms occupying part of the Buildings and bounded from a point at the center of the framed perimeter wall (i.e., the center of the studs), ceiling, and floor inward to the interior of the individual air space unit, including but not limited to: the wood framing; sheetrock (or other wall board), including interior surfaces and wall coverings and decorations; plumbing; pipes; ducts; flues; chutes; conduits; wires and other utility installations; floors; ceilings; windows; doors along the perimeter boundaries of the air space unit, as said boundaries are shown on the Map, and all fixtures and improvements therein contained. Paint and other wall, ceiling, or floor coverings on interior surfaces shall be deemed to be a part of the Unit. Notwithstanding the fact that they may be within the boundaries of such air space, the following are not part of a Unit insofar as they are necessary for the support or for the use and enjoyment of another Unit: Bearing walls, roofs, foundations, tanks, pumps, vents, and other utility installations common to more than one Unit, except the outlets thereof when located within the Unit. The heating, ventilation, and air conditioning equipment and insulation for a particular Unit and used exclusively in or surrounding that Unit shall be part of that Unit.

2. Section 12.05 of the Restated Declaration shall be amended in its entirety to read as follows:

12.05. Owner's Own Insurance and Liability. Notwithstanding the provisions hereof, each Owner shall obtain a broad form of comprehensive liability insurance coverage, in such amounts (but in no event less than \$1.0 Million per occurrence) and in such forms as he or she deems advisable to provide adequate protection against liability for personal injury, death, and property damage. Each Owner may obtain other insurance at such Owner's own expense providing coverage for his or her Condominium, his or her personal property; and covering such other risks as such Owner may deem appropriate; provided, however, that each such policy shall provide that it does not diminish the insurance carrier's coverage for liability arising under insurance policies obtained by the Association pursuant to this Declaration. Owners are encouraged to obtain Property A Coverage insurance, as an additional rider to their policies in an amount sufficient to fully cover or fully replace private ownership areas of their Units. This coverage should include automatic inflation or value adjustment. Any event, whether intentional, negligent or accidental, originating from a particular Unit or its Limited Common Areas which causes damage to any other Unit, Limited Common Area or the Common Area, is considered the economic responsibility of the Owner of the Unit which was the source of the event leading to the damage up to, but not exceeding, \$1.0 Million, and each Owner is encouraged to insure for such risks.

3. Definitions and Confirmation. All terms used in this Fifth Amendment shall have the same meaning and import as given in the Restated Declaration. Except as expressly and specifically amended herein, the Restated Declaration, as amended, is hereby confirmed as originally executed and recorded.

IN WITNESS WHEREOF, the consents and agreements as required by the Restated Declaration, as amended, have been obtained and this Fifth Amendment was executed as of the day and year first above written.

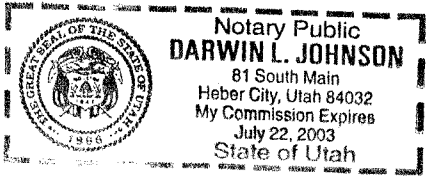

