The UTAH DEPARTMENT OF TRANSPORTATION, by its duly appointed Director of Right of Way, Grantor, of Salt Lake City, County of Salt Lake, State of Utah, hereby QUIT CLAIMS to U.S.B. PROPERTIES, LTD., Grantee, at BOUNTIFUL, County of DAVIS, State of UTAH, Zip 84010, for the sum of TEN DOLLARS & OTHER GOOD & VALUABLE CONSIDERATION---Dollars, and other good and valuable considerations, the following described tract of land in Davis County, State of Utah, to-wit: TAX I.D.06-003-0025

A tract of land in, situate in the NE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 12 and in the SE $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 1, all in T. 2 N., R. 1 W., S.L.B. & M. The boundaries of said tract of land are described as follows:

Beginning at the intersection of the south line of said Section 1 and the westerly right of way line of the existing Union Pacific Railroad, which point is 27.103 m (88.92 ft.) N 89°57'31" W (deed of record S 89°58'05" W) along the section line from the Southeast corner of said Section 1 as monumented with a county Brass Cap; and running thence S 0°19'16" W 7.224 m (23.70 ft.), more or less, along said westerly railroad right of way line to the southerly boundary line of said entire tract; thence N 89°48'02" W (deed of record Westerly) 290.426 m (952.84 ft.), more or less, along said southerly boundary line to the easterly right of way line of a highway known as Project No. 0067; thence along said easterly right of way line the following two (2) courses: (1) N 49°25'03" E 31.394 m (103.00 ft.) to a point of tangency with a 148.000 m (485.56 ft.) radius curve to the left; thence (2) Northeasterly 100.623 m (330.13 ft.) along the arc of said curve to the northerly boundary line of said entire tract

(Note: Chord to said curve bears N 29°56'25" E for a distance of 98.696 m (323.81 ft.)); thence S 89°57'31" E (deed or record East) 217.852 m (714.74 ft.), more or less, along said northerly boundary line to said westerly railroad right of way line; thence S 0°16'53" W (deed of record Southerly) 99.578 m (326.70 ft.) along said westerly railroad right of way line to the point of beginning. The above described tract of land contains 25,978.5 square meters (6.420 acres), more or less.

Subject to all matters which an accurate survey or a thorough physical inspection of the Property would disclose and all matters arising by, through or under Grantees or Grantees agents.

Signs, Billboards, outdoor Advertising structures, or advertising of any kind as defined in 23 United States Code, Section 136, shall not be erected, displayed, placed or maintained upon or within this tract, EXCEPT signs to advertise the sale, hire or lease of this tract or the principal activities conducted on this land.

The grantor reserves rights to use the abutting state property for highway purposes and excludes from this grant any rights to air, light, view and visibility over and across the abutting state property. The Grantee is hereby advised that due to present or future construction on the adjacent highway including but not limited to excavation, embankment, structures, poles, signs, walls, fences and all other activities related to highway construction or which may be permitted within the Highway Right of Way that air, light, view and visibility may be restricted or obstructed on the above property.

Pursuant to Title 72, Chapter 6, Section 117, Utah Code Annotated, 1998, as amended, the above described tract of land is granted without access to or from the adjoining expressway over and across the westerly boundary line of said tract of land.

Together with and subject to any and all easements, rights of way and restrictions appearing of record or enforceable in law and equity.

Junkyards, as defined in 23 United States Code, Section 136, shall not be established or maintained on the above described tracts of lands.

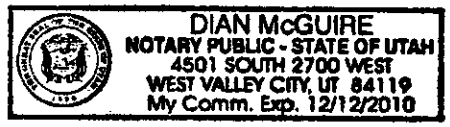
