AGREEMENT TO AMEND RECIPROCAL EASEMENT AGREEMENT

WITNESSETH:

WHEREAS, on the 6th day of December, 1972, Arbor Park
Shopping Center, a partnership, as First Party, and Artic Circle,
a corporation, as Second Party, and Zions First National Bank,
N. A., as Third Party, executed a Reciprocal Easement Agreement,
which Reciprocal Easement Agreement was recorded January 30, 1973,
in Book 3248, Page 311, Records of Salt Lake County, State of

WHEREAS, the parties now desire to amend said Reciprocal Easement Agreement by correcting the spelling of "Artic" and correcting the legal status of the Arctic Circle and amending the description contained therein;

NOW, THEREFORE, in consideration of the premises, covenants and agreements, and the mutual promises of the parties hereto, it is hereby agreed as follows:

- l. That the designation of "Artic Circle, a corporation," in said Reciprocal Easement Agreement, be deleted and inserting therein in lieu thereof wherever the words "Artic Circle, a corporation" appear in said Agreement, the following: "Helen Gust Young dba Arctic Circle".
- 2. That the description of the property in the Reciprocal Easement Agreement owned by Arbor Park Shopping Center, a
 partnership, and recorded in Book 3248, Page 311, is hereby amended
 by addition of the following two tracts of land described as
 Tracts 1 and 2:

TRACT 1: BEGINNING at a point which is North 89°55' East 651.80 feet and South 0°12' East 454.93 feet and West 60 feet from the North Quarter Corner of Section 32, Township 1 South, Range 2 West, Salt Lake Base and Meridian, and running thence West 40 feet; thence South 0°12' East 120 feet; thence East 40 feet; thence North 0°12' West 120 feet to the place of beginning.

TRACT 2: BEGINNING at a point which is North 89°55' East 651.80 feet and South 0°12' East 454.93 feet and West 60 feet and South 0°12' East 120 feet and West 100 feet from the North Quarter Corner of Section 32, Township 1 South, Range 2 West, Salt Lake Meridian, and running thence West 40 feet; thence South 0°12' East 160 feet; thence East 40 feet; thence North 0°12' West 160 feet to the place of beginning.

That except as amended, said Reciprocal Easement Agreement shall remain exactly as now written and all terms shall apply to both the original property as described in the Trust Deed and the two tracts added by this amendment.
