**ADMINISTRATIVE ORDER OF THE CITY ENGINEER OF OGDEN CITY
CHANGING THE PROPERTY ADDRESS OF PARCEL# 12-023-0041**

NOW THEREFORE, IT IS HEREBY ORDERED that


A. Changes to the following property addresses shall be as noted below:

Also described as: PART OF THE SOUTHWEST QUARTER OF THE NORTHWEST QUARTER OF SECTION 16, TOWNSHIP 6 NORTH, RANGE 1 WEST, SALT LAKE MERIDIAN, DESCRIBED AS FOLLOWS: BEGINNING AT A POINT 21.60 CHAINS SOUTH 3.525 CHAINS SOUTH 89D45' EAST AND .61 CHAINS SOUTH 0D15' WEST OF THE NORTHWEST CORNER OF SAID NORTHWEST QUARTER SECTION, SAID POINT BEING ON THE SOUTH LINE OF 2ND STREET IN OGDEN CITY, WEBER COUNTY, UTAH, AND RUNNING THENCE SOUTH 0D15' WEST 150 FEET, THENCE NORTH 89D45' WEST 50 FEET, THENCE NORTH 0D15' EAST 150 FEET TO THE SOUTH LINE OF 2ND STREET, THENCE SOUTH 89D45' EAST ALONG THE SOUTH LINE OF 2ND STREET 50 FEET TO THE PLACE OF BEGINNING.
