## **EASEMENT**

WE, THE UNDERSIGNED owners of real property situated and located in Utah County, State of Utah, do hereby convey, grant, and release to LEHI CITY, Utah County, State of Utah, a perpetual easement and right-of-way for certain **\_Public Utilities\_** and related facilities, over, under, and through the following described real property situated in Utah County, State of Utah, and more particularly described as follows:

## 10' wide Center Street Public Utility Easement

A part of the Southwest Quarter of Section 33, Township 4 South, Range 1 East, Salt Lake Base and Meridian, U.S. Survey, Utah County, Utah

Beginning at point on the Easterly line of Center Street, being 53.21 feet South 0°05'36" East along the Section line and 57.30 feet North 89°54'24" East from the West Quarter Corner of said Section 33, and running thence South 45°00'22" East 10.00 feet; thence South 46°46'13" West 14.14 feet to a point of curvature; thence Southwesterly along the arc of a 30.00 foot Radius curve to the left a distance of 9.28 feet (Delta Angle equals 17°43'46", Long Chord bears South 37°54'20" West 9.25 feet); thence South 0°05'36" East 1258.22 feet; thence South 89°29'33" West 10.00 feet to said Easterly line of Center Street; thence three (3) Courses along said Easterly line as follows: (1) North 0°05'36" West 1260.69 feet to a point on the arc of a curve; (2) Northeasterly along the arc of a 40.00 foot radius curve to the right a distance of 15.15 feet (Delta Angle of 21°42'07"; Center bears South 64°55'53" East, Long Chord bears North 35°55'10" East 15.06 feet) to a point of tangency; and (3) North 46°46'13" East 13.83 feet to the point of beginning.
