FIRST AMENDMENT TO AMENDED AND RESTATED DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS OF PEACEFIELD PLANNED UNIT DEVELOPMENT

This First Amendment to AMENDED AND RESTATED DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS OF PEACEFIELD PLANNED UNIT DEVELOPMENT, ("Declaration") which was recorded in the offices of the Davis County Recorder, June 9, 2011, as Entry No. 2602397, is made and executed as of this 24th day of January, 2012, by the Peacefield Homeowners Association ("Declarant") after a vote of the Members of the Association at a duly noticed, called and conducted meeting of the same.

WHEREAS, the Declarant and Members have determined that in the best interest of the Owners of all Lots and Units covered by the Declarations, it is required to amend the Declarations.

THEREFORE, the Declarant, with the approval of the required votes of the Members at a duly noticed meeting, hereby amends the Declaration as follows:

1. Page 14, Section VI. 3.:

Delete "Assessments shall not be levied on Lots owned by the Developer which have not been sold in connection with the marketing and development of the Planned Unit Development."

And Insert "Lots in Phases 1, 2, & 4 (Class A) owned by the Developer which have not been sold in connection with the marketing and development of the Planned Unit Development will be assessed at 50% of the annual assessment. Lots in Phases 3, 5, & 6 (Class B) owned by the Developer which have not been sold in connection with the marketing and development of the Planned Unit Development will be assessed at 50% of the annual assessment. If the developer is building a home on any of the lots (Phases 1-6, either Class A or B) then the assessment will remain at 50% until the home is occupied."

2. Page 15, Section VI. 7.:

Delete "; provided, however that assessments may not accrue against the Developer or against lots owned by the Developer which are available for sale but not yet sold"

3. Page 18, Section VIII. 4. c.:

Delete "For purposes of this subsection, for Lots in Plats 3, 5, and 6, the square footage of the garage area shall be included in the first floor calculation and the minimum square feet of habitable space on the second floor shall be 800 square feet."

Except as specifically set forth herein, the terms of the Declaration shall remain unchanged. If
