The Board of County Commissioners of Rich County, State of Utah, hereby certify that on May 3, 1978, the Bear Lake Special Service District of Rich County, Utah was duly created by resolution and pursuant to Section 11-23-1 et. seq. of the Utah Code Annotated, 1953 as amended, and that the geographical boundaries of said District were identified and set forth in said RESOLUTION of said date, the same being made a part of the official records of Rich County, Utah, and held by the Clerk of Rich County.

The geographical boundaries of said District were expanded by ANNEXATION pursuant to law and RESOLUTION of the Board of County Commissioners of Rich County, State of Utah on May 7, 1980.

This further certifies that the geographical boundaries of the Bear Lake Special Service District of Rich County, Utah are and have been since May 7, 1980, legally described as follows:

Beginning at the South line of Section 3, Township 13 North, Range 5 East, Salt Lake Base and Meridian, where it intersects Bear Lake (elevation 5923.65'), thence West along the South line to the West side of State Route 30, thence in a Northern direction parallel to the West side of State Route 30 to where State Route 30 intersects with Sweetwater Parkway, thence South 500 feet along Sweetwater Parkway, thence in a West and Northerly direction paralleling State Route 30 (500 feet from the highway) to a point where it intersects the South line of Section 21, Township 14 North, Range 5 East, Salt Lake Base and Meridian, thence West along said line to a point 750 feet from the West side of State Route 30, thence North to a point in the Southwest

quarter of Section 16, Township 14 North, Range 5 East, Salt Lake Base and Meridian, 600 feet Southwest from the West side of the State Route 30, thence in a northerly direction parallel to the West side of State Route 30 (600 feet from the highway) to a point where it intersects the South line of Section 32, Township 15 North, Range 5 East, Salt Lake Base and Meridian, thence West along said line to the center of the North line of Section 6, Township 14 North, Range 5 East, Salt Lake Base and Meridian, thence North to the Utah state line, thence East to the Bear Lake shore line (elevation 5923.65'), thence in a Southern direction along the lake shore to the point of beginning.

INCLUDING THEREWITH:

Beginning at the East Quarter Corner of Section 7, Township 14 North, Range 5 East, Salt Lake Base and Meridian, and running thence North $89^{\circ}13'15''$ West, 726 feet; thence North $19^{\circ}29'50''$ East, 1413.4 feet, thence North $0^{\circ}25'05''$ East, 1338.67 feet, more or less, to the North line of Section 7; thence North $0^{\circ}23'50''$ East, 2150 feet; thence South $89^{\circ}10'30''$ East, 264 feet, more or less, to the East line of Section 6, Township 14 North, Range 5 East, Salt Lake Base and Meridian; thence North $0^{\circ}23'50''$ East along said East line 450 feet, more or less, to the centerline of Swan Creek; thence Westerly along the centerline of Swan Creek 270 feet, more or less, thence South $0^{\circ}23'50''$ West, 250 feet, more or less to the Garden City Canal; thence Westerly along the Garden City Canal 1164 feet, more or less; thence North $0^{\circ}23'40''$ East, 2170 feet; thence South $89^{\circ}10'30''$ East, 1320.06 feet, more or less, to the East line of Section 6; thence South $0^{\circ}23'50''$ West, along the East line of Section 6, 1320.86 feet, more or less, to the East Quarter corner of Section 6; thence South $89^{\circ}10'30''$ East, 363 feet; thence South $57^{\circ}35'$ East, 1124.3 feet; thence South $0^{\circ}26'33''$ West, 120 feet, more or less, to the centerline of Swan Creek; thence Easterly along the centerline of Swan Creek 993 feet, more or less, to the Westerly Right-of-Way line of U.S. Highway 89; thence Southeasterly along said Right-of-Way line 2799 feet, more or less, to the South line of Section 5, Township 14 North, Range 5 East, Salt Lake Base and Meridian; thence North $89^{\circ}10'30''$ West along said South line 160 feet; thence South $0^{\circ}34'$ West, 2673.98 feet, more or less, to the South line of the Northeast Quarter of Section 8; thence North $89^{\circ}13'15''$ West, along said South line 1316.30 feet, more or less, to the Center of Section 8; thence South $0^{\circ}29'15''$ West, along the East line of Southwest Quarter of Section 8, 2675.04 feet, more or less, to the South Quarter Corner of Section 8; thence North $88^{\circ}49'10''$ West, along the South line of Section 8, 2613.91 feet more or less, to the Southwest Corner of Section 8; thence North $0^{\circ}13'20''$ East, along the West line of Section 8, 2656.84 feet, more or less, to the point of beginning.

Beginning at the South Line of Section 3, Township 13 North, Range 5 East, Salt Lake Base and Meridian, where it intersects Bear Lake (elevation 5923.65 feet); thence West along the South Line of said Section 3 to the Westerly Right-of-Way Line of State Highway Route 30; thence in a Northerly to Westerly direction along said Right-of-Way Line to where it intersects the Easterly Rightof-Way Line of Sweetwater Parkway; thence Southerly 500 feet along Sweetwater Parkway; thence Northwesterly parallel to said State Highway Route 30 to the East Line of Section 4, Township 13 North, Range 5 East, Salt Lake Base and Meridian; thence Southerly along said East Line to the Southeast corner of Section 4, Township 13 North, Range 5 East, Salt Lake Base and Meridian; thence Westerly along the South Line of Section 4 for a distance of 1,320 feet, more or less, to the E 1/16 Corner; thence Northerly 3,960 feet, more or less, to the NE 1/16 Corner of said Section 4; thence Westerly 1,320 feet, more or less, to the N 1/16 Corner of said Section 4; thence Northerly 1,320 feet, more or less, to the N 1/4 Corner of said Section 4; thence Westerly 1,320 feet, more or less, to the W 1/16 Corner of Section 33, Township 14 North, Range 5 East, Salt Lake Base and Meridian; thence Northerly along the West 1/16 Line of Section 33, for a distance of 5,280 feet, more or less, to the North Line of said Section 33; thence Westerly along the North Line of Section 33 for a distance of 660 feet; thence North to a point 500 feet Southwesterly (perpendicular distance) from the Southwesterly Right-of-Way Line of State Highway Route 30; thence Northerly along a line parallel to and 500 feet perpendicular distance from the said State Highway Right-of-Way Line to the Southern Limits of Garden City, Utah; thence North $89^{\circ}03'40''$ West, 1,443.47 feet; thence South $20^{\circ}09'11''$ East, 105.14 feet; thence South $6^{\circ}44'08''$ West, 95.12 feet; thence South $24^{\circ}35'14''$ East, 140.94 feet; thence South $14^{\circ}07'19''$ West, 110.64 feet; thence South $38^{\circ}06'33''$ West, 237.62 feet; thence North $89^{\circ}39'34''$ West, 800.91 feet; thence North $0^{\circ}41'55''$ East, 1,341.89 feet; thence South $0^{\circ}48'35''$ East, 1,333.39 feet to the Southwest Corner of Section 21, Township 13 North, Range 5 East, Salt Lake Base and Meridian; thence North $0^{\circ}51'27''$ East, 951.06 feet; thence South $88^{\circ}50'15''$ East, 953 feet, more or less, to a point in a line parallel to and 100 feet West (perpendicular distance) of the Westerly Limits of Garden City, Utah; thence North along said parallel line to a point 750 feet North of the South Line of Section 16, Township 14 North, Range 5 East, Salt Lake Base and Meridian; thence West to a point in the West Line of said Section 16, said point is 750 feet North of the Southwest Corner of said Section; thence North along the said West Line of Section 16 approximately 730 feet to the South Line of Tax Parcel B-216; thence East 324 feet,

more or less, to the Southeasterly corner of the said Tax Parcel B-216; thence North along the Easterly line of Tax Parcel B-216 to a point that is 600 feet Westerly (perpendicular distance) for the Southwesterly right-of-way line of U. S. Highway 89; thence Northerly along a line parallel to and 600 feet Westerly (perpendicular distance) from the said Westerly Right-of-Way Line of U. S. S. Highway 89; thence Northerly along a line parallel to and 600 feet Westerly (perpendicular distance) of the said Highway Right-of-Way Line to the South Line of Section 32, Township 13 North, Range 5 East, Salt Lake Base and Meridian; thence Westerly along the South Line of said Section 32 and Section 33 to the South 1/4 Corner of Section 33, Township 13 North, Range 5 East, Salt Lake Base and Meridian; thence Northerly along the Meridional Centerline of the said Section 33 to the Utah State Line; thence Easterly along the Utah State Line to the Bear Lake Shore (elevation 5223.65 feet); thence in a Southerly direction along the Lake Shore to the Point of Beginning. This description of the boundaries of the "Bear Lake Special Service

District" is based on bearings and distances of record and does not represent a field survey.

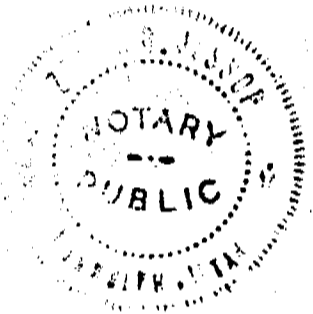

RESOLUTION ESTABLISHING A SERVICE DISTRICT
FOR
FIRE PROTECTION AND AMBULANCE SERVICE

BE IT RESOLVED by the Board of County Commissioners of Rich County, State of Utah, as follows:

That Whereas the elected officials of some of the towns of Rich County have requested that a service district for fire protection and ambulance service be established, and

Whereas the public health, convenience, and necessity requires that a service district for fire protection and ambulance service be established,

Whereas a public hearing on the establishment of said service district was held pursuant to legal notice on the 7th day of July, A. D. 1976 at 1:30 p.m. in the Rich County Courthouse, and

WHEREAS it appears that a majority of the voters in Rich County favor the establishment of a service district for fire protection and ambulance service,

NOW, THEREFORE, it is hereby RESOLVED as follows:

1. A service district for fire protection and ambulance service is hereby established within the boundaries of Rich County as set forth in the attached Exhibit "A".
2. The name of the proposed service district shall be
GARDEN CITY - PICKELVILLE FIRE DISTRICT
3. That said Service District shall have all the powers granted by Chapter 23 of Title 11 of the Utah Code.
4. That there is established an Advisory Board for said Service District consisting of three persons who shall be appointed by the Board of County Commissioners of Rich County, Utah, for terms of four years, except that the term of one member of the first Advisory shall be for two years as provided by law. In addition each municipality within the boundaries of said Service District may appoint one member of the Advisory Board of said District to represent said municipality as provided by State law. Said Advisory Board shall have all the
