PHASE I, Phase I Amended

THIS AMENDMENT TO THE DECLARATION OF CONDOMINIUM OF GREEN VALLEY CONDOMINIUMS (hereinafter "the Amendment to the Declaration"), is made by JOYNER CONSTRUCTION, INC. (hereinafter collectively "the Declarant).

RECITAL

WHEREAS, on the 3rd day of March 1993, that certain instrument captioned "Declaration of Condominium of Green Valley Condominiums" (therein and herein "The Declaration"), consisting of 40 pages, including Exhibits "A", "B", and "C", thereto attached, was filed for record by the Declarant in the office of the County Recorder of Utah County, Utah, in Book 3097, page 282 as Entry No. 12594, Green Valley Condominiums, hereinafter recited reference is hereby made for all purposes; and

WHEREAS, that certain instrument captioned "Record of Survey Map of Green Valley Condominiums," prepared by Allen Consulting Surveyors and certified by Don Allen, Utah registered land surveyor, professional engineer, was filed of record simultaneously with the Declaration by the Declarant in said Office of the County Recorder as Entry No. 27210, assigned Map Filings No. 6044; and

WHEREAS, the Declaration (in Article IV) expressly reserved to the Declarant the right to expand the Green Valley Condominiums, Condominium Project ("the Project"), which right included the method of expansion, the right to adjust percentages of Common Areas and other provisions relative thereto as all therein set forth; and

WHEREAS, the Declarant now proposes to expand the project pursuant to the provisions of said Article IV of the Declaration to encompass the tracts of land hereinafter described,

SUPPLEMENTARY DECLARATION

1. Expansion of Definitions. The definitions used in the Declaration (wherever the context so admits as applied to the Amendment to the Declaration) shall be so expanded to encompass and refer to the project as hereby expanded.

Submission of Additional Tracts to Condominium Project. the Declarant hereby submits the following described tracts of land in the County of Utah (hereinafter sometimes referred to as "Phase II"), to-wit:

including all buildings and other improvements constructed thereon, together with all appurtenances thereto, and subject to all the covenants, conditions, and restrictions as hereinafter provided, to the Provisions of the Utah Condominium Ownership Act, so that such additional Buildings, Improvements and Appurtenances and the initial Condominium Project created by the Declaration shall in every respect be treated as integral parts of a single condominium ownership Project.

- Name. The phase III lands, buildings, improvements and appurtenances hereby submitted to the provisions of the Act shall be known as Green Valley Condominium, Phase III.
- Development Plans. This Phase, constituting expanded area of the Project will include the six (6) buildings containing a total of eleven (12) units, as shown on the supplemental record of survey map (the supplemental map), prepared and certified by Don Allen, engineer, which is filed simultaneously herewith.
- <u>Proportionate Ownership in Common Areas</u>. The Phase III unit owners' proportionate ownership in the common areas of the Project as expanded, shall be set forth in Exhibit "B", hereto attached and made a part hereof. The expanded project will be managed, treated and governed in all respects as one condominium project without regard to phases, it being intended that references to phases in the Declaration and herein being made are for The provisions of Article IV of the Declaration convenience only. reserving to Declarant the right to adjust percentages of common areas of the original condominium shall likewise apply to the Phase III area.
- Amendment of Ownership of Unit Owners of Phase III in the Common Areas. Pursuant to the provisions of Article IV of the Declaration reserving to Declarant the right to adjust the percentages of the Unit Owners; ownership in the common area upon the project being expanded, the Declarant hereby declares and certifies that from and after the recordation hereof int the Office of the County Recorder of Utah County, Utah, the proportionate ownership of unit owners of Phase I in the common areas of the Project, as expanded, shall be as set forth in the part of said Exhibit "B", captioned "Phase III -- Amended Percentages of Ownership in the Common Areas."

7. Area of Land Covering the Project After Expansion. The Project as expanded here by encompasses the following described tracts of land in Utah County, Utah, to-wit:

- 8. <u>Incorporation by Reference of this Declaration</u>. All and singular the provisions of the Declaration of Condominium of Green Valley Condominiums, together with the Bylaws, wherever the context so admits as applied to Phase I area, are hereby adopted herein by reference and made a part hereof as if the same were fully set forth herein.
- 9. Parking areas: Guest parking will be provided in each phase as follows.

parking stalls for 8 cars in phase I parking stalls for 6 cars in phase II parking stalls for 6 cars in phase III

The Association may at its approval and expense provide in additional to that listed above, parking stall as they deem necessary. Recorded maps/plats of each phase may show where additional parking maybe located, but these area may or may not be used.

10. Weather: Unit owners are responsible for snow and ice removal. Although the association may hire snow removal to be done when the depth of the snow reaches more than two inches, it is still the unit owners responsibility to make sure their walks are cleaned off. The declarant is hereby held harmless in regards to any weather related conditions, or problems.

11. <u>Insurance:</u> Each unit owner is responsible to pay any and all deductibles on any and all claims made on their unit. Any item not covered under the master policy will be the responsibility of the unit owner.
