AMENDMENT TO THE SYSTEM IMPROVEMENTS PARTICIPATION/REIMBURSEMENT AGREEMENT DATED AUGUST 2019

WHEREAS, Payson is the owner of a sewer lift station on the east side of the City near Highway 198: and

WHEREAS, South Haven Farms LC is a development on the east side of the City as described in Exhibit A, that is required to utilize the City owned lift station across Highway 198: and

WHEREAS, in August 2019 Payson and South Haven Farms LC entered into the System Improvements Participation/Reimbursement Agreement ("Agreement"); and

WHEREAS, the Agreement contemplated upgrades to the sewer lift station; however, litigation regarding the lift station between Mr. Phillips and the Army Corp. of Engineers, prevented the upgrades or inclusion in the Agreement: and

WHEREAS, the litigation regarding the lift station has concluded and the parties desire to amend the Agreement and add the costs of the upgrade lift station; and

WHEREAS, the parties desire to add this Amendment to amend certain provisions of the Agreement; and

WHEREAS, all other provision of the Agreement shall remain and are hereby affirmed.

NOW THEREFORE, the parties hereto contract, covenant, and agree as follows:

- 1. Section 2, the title shall be amended to Sanitary Sewer Line and Lift Station. The body of Section 2 shall be amended adding the following at the end of the paragraph stating, The lengths and dimensions of pipe/lift station upgrades and other associated materials and costs related to upsizing of the lift station and sanitary sewer piping are set forth in Exhibit B Addendum. The Parties agree that South Haven Farms, LC has met its obligations to Payson City in full regarding their requirement to help pay for the initial cost of the lift station. Exhibit B Addendum includes the amounts that South Haven Farms, LC was initially required to pay toward the lift station.
