A parcel of land in fee, being part of an entire tract of land, situate in the SE Quarter of Section 17, Township 6 North, Range 3 West, Salt Lake Base and Meridian, Incident to the construction of 1200 South Street, Weber County, State of Utah also known as Project No. LG_WC_1200 S. The boundaries of said parcel of land are described as follows:

Beginning at a point on the existing North right of way line of 1200 South Street on the West line of the Grantor's property, said point lies 25.00 feet North 89°50'00" East along the South line of the SE Quarter of said Section 17 and 50.00 feet North 00°02'24" East from the SW Corner of the SE Quarter of said Section 17; and running thence North 00°04'03" East 1.29 feet along the West line of said Grantor's property; thence South 89°51'12" East 236.38 feet to a point on the South line of said Grantor's property; thence South 89°50'00" West 236.38 feet along the South line of said Grantor's property to the Point of Beginning.

Rotate 0°26'18" Glockwise to match highway bearing.


