Survey: Beginning at the Northwest corner of Lot 9, Block 1, BELLEVUE PLACE ADDITION TO OGDEN CITY, Weber County, Utah; and running thence South along the State Highway 200 feet; thence East 494 feet; thence North 320 feet to the No1i:h boundary of the Van Dyke property; thence West along said property line 248 feet to the East boundary line of Bellevue Place Addition to Ogden City; thence South along East boundary of Bellevue Place Addition to Ogden City 120 feet to the Northeast corner of Lot 1, Block 1, Bellevue Place Addition to Ogden City; and thence West along the North boundary of Block I to the place of beginning.
