WARRANT to CALVIN S. RASMUSSEN AND DOROTHY G. RASMUSSEN, his
wife, AS TENANTS IN COMMON AND NOT AS JOINT TENANTS, Grantees
of Salt Lake County, State of Utah, for Ten Dollars (\$10.00)
and other good and valuable consideration, the following
described tract of land in Salt Lake County, State of Utah:

Commencing at a point 364.5 feet West of the Northeast
Corner of Lot 6, Block 28, Plat "B", Salt Lake City Survey,
and running thence South 107 feet; thence West 10.5 feet;
thence South 38 feet; thence East 15 feet; thence South
20 feet; thence West 60 feet; thence North 165 feet; thence
East 55.5 feet to the point of beginning. Together with
a right-of-way over the following described tract of land,
to-wit: --Commencing at a point 355.5 feet West of the
Northeast Corner of Lot 6, Block 28, Plat "B", Salt Lake
City Survey and running thence South 107 feet; thence
East 10.5 feet; thence South 38 feet; thence West 30 feet;
thence North 38 feet; thence East 10.5 feet; thence North
107 feet; thence East 9 feet to the point of beginning.

thence North 76 feet to the place of beginning.

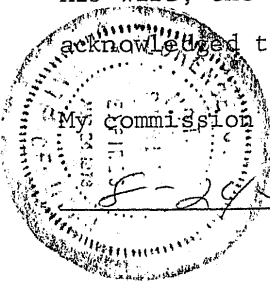
