EASEMENT

Morton International
 a corporation of the State of Delaware, Grantor,
 hereby grants and conveys to Rulon Milo Higley, Grantee, for the sum of \$1.00
 (One Dollar) Dollars,
 an easement upon part of an entire tract of property in the NE $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 5,
 T. 2 S., R. 5 W., S.L.B.&M., in Tooele County, Utah, for the purpose of constructing
 and maintaining thereon a drainage facility and appurtenant parts thereof incident
 to the construction of a freeway known as Project No. 80-2.

Said part of an entire tract is a parcel of land 20 feet wide by 100 feet
 long, more particularly described as follows:

Beginning at a point approximately 732 feet west and 105 feet south of the
 north quarter corner of said Section 5; thence S. 38°12'15" E. 20 feet; thence
 S. 51°47'45" W. 100 feet; thence N. 38°12'15" W. 20 feet; thence N. 51°47'45" E.
 100 feet to the point of beginning.

It is agreed that access across the grantor's land will be granted to the
 grantee for maintenance of said drainage facility.

The above described parcel of land contains 0.046 acre, more or less.

After said drainage facility is constructed on the above described part of
 an entire tract at the expense of the State Road Commission, said State Road
 Commission is thereafter relieved of any further claim or demand for costs,
 damages or maintenance charges which may accrue against said drainage facility
 and appurtenant parts thereof.
