BEVAN, his wife, and INTERNATIONAL SMELTING COMPANY, a corporation, dated June 24, 1916, and recorded on June 26, 1916 at Book "C" of Liens & Leases, Page 144, Records of Tooele County, Utah, and covering the following described real property located in Tooele County, Utah, to-wit:
