Easement For Right of Way

This Deed, Made this 13th day of October, in the year of our Lord one thousand nine hundred and twelve, between the Salt Lake Mattress and Manufacturing Company, a corporation duly organized and existing under and by virtue of the laws of the State of Utah, party of the first part, and The Denver And Rio Grande Railroad Company, a consolidated corporation organized and existing under and by virtue of the laws of the State of Colorado and of the State of Utah, party of the second part.

Witnesseth

That the said party of the first part, for and in consideration of the sum of One Dollar (\$1.00) and other good and valuable considerations to the said party of the first part in hand paid by the said party of the second part, has granted and by these presents doth grant unto the said party of the second part its successors and assigns, forever, the right, privilege and easement to construct, operate and maintain a spur track across land of the party of the second part in Lot 7, Block 46, Plat "A", Salt Lake Survey, more particularly described as follows:


Beginning at a point 16.5 feet East and 158 feet South of the Northwest corner of said Lot 7 and running East ~~175~~ 66 feet, more or less, to Easterly Boundary of Grantor's Land.

To Have and To Hold the same, together with all and singular the appurtenances and privileges therunto belonging or in any way appertaining, and all the estates, right, title, interest and claim whatsoever of the said party of the first part, either in law or equity, in and to the easement herein and hereby granted for the only proper use, benefit and behoof of the said party of the second part, its successors and assigns, forever.




