EASEMENT

its successors in interest and assigns, Grantee, for the sum of One (\$1.00) Dollar and other valuable
consideration, a perpetual easement and right of way for the erection, operation and continued
maintenance, repair, alteration, inspection, relocation and replacement of the electric transmission and
distribution circuits of the Grantee, with the necessary poles, towers, guys, stubs, crossarms, braces
and other attachments affixed thereto, for the support of said circuits, on, over and across a tract
of land located in Salt Lake County, Utah, a right of way 26 feet wide,
being 13 feet each side of the following described line:

Beginning on the east boundary line of the Grantors' land at a point 34 feet
north, more or less, from the southeast corner of Section 10, T.3 S., R.2 W.,
S.L.M., thence N.89°56'W. 1320 feet, more or less, to the west boundary line
of said land and being in the SE 1/4 of the SE 1/4 of said Section 10.

Except from the above that portion of line over, across, and/or upon County Road
right of way.

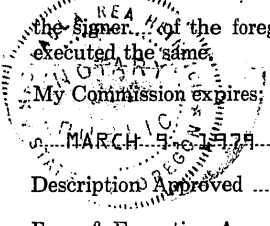
