AN ORDINANCE AMENDING THE ZONING MAP OF SANTAQUIN CITY TO INCLUDE THE GREENHALGH ADDITION ANNEXATION AREAS LOCATED ADJACENT TO THE CURRENT CORPORATE BOUNDARIES OF SANTAQUIN CITY, UTAH

WHEREAS Richard Greenhalgh and Rex Greenhalgh (the "Petitioners"), petitioned to annex the real property described in Exhibit A (the "Property") to the City; and

WHEREAS the Petitioners own the majority of the privately owned real property within the annexation area; and

WHEREAS the applicable public entities have received notice of the proposed annexation and amendment to the official zone map; and

WHEREAS, on January 21, 2004, the City Council held a public hearing to receive input on the proposed annexation and zoning; and

WHEREAS Santaquin City, Utah desires to amend the Official Zone Map of Santaquin City to include the property within the City's regulatory boundary.

NOW, THEREFORE BE IT ORDAINED by the City Council of Santaquin City, Utah as follows:

<u>SECTION</u> 1. <u>Official Zone Map Amended</u>. The Official Zone Map of Santaquin City as adopted by section 02.0802 of the Santaquin City Zoning Ordinance, is hereby amended to include the annexed real property as depicted in Exhibit A.

SECTION 2. Designation. The amended area shall be zoned Commercial (C).

- SECTION 3. Execution of Documents. The Mayor is hereby authorized to execute AMENDED ARTICLES OF INCORPORATION OF THE CITY OF SANTAQUIN and a certification of the Santaquin City Council that the legal procedures for annexation have been completed.
- **SECTION** 4. Posting. A copy of this Ordinance shall be deposited in the office of the Santaquin City Recorder, and on March 4, 2004, the Santaquin City Recorder shall certify that this Ordinance has been posted in three public places within the municipality, as provided in Utah Code Annotated § 10-3-711(1).

SECTION 5. Effective Date. This Ordinance shall take effect on March 4, 2004, and the described annexation shall be completed upon certification by the office of the Utah Lt. Governor.
