FIRST AMENDMENT TO THE AMENDED DECLARATION OF RIDGEWOOD CONDOMINIUM

This First Amendment to the Amended and Restated Declaration of Ridgewood Condominium ("Declaration") is executed on the date set forth below by the Ridgewood Owners' Association ("Association").

RECITALS

- A. Real property in Davis County, Utah, known as Ridgewood Condominium is subject to covenants, conditions, and restrictions pursuant to the Amended and Restated Declaration recorded September 5, 2014 as Entry No. 2822022, Book 6096, Page 216, records of Davis County, Utah;
- B. The Association desires to amend the Declaration to include a reinvestment fee and leasing provisions;
- C. This amendment shall be binding against the property described in EXHIBIT A, attached hereto and incorporated herein by reference;
- D. The provisions of this amendment shall supersede and control over any conflicting provisions in the Declaration;
- E. Pursuant to Article XIX of the Declaration, by executing below the Management Board certifies that 67% of the Total Votes of the Association approved this Amendment;

NOW, THEREFORE, the Association hereby amends the Declaration as follows:

Article X of the Declaration is hereby amended to add Section 13, which reads as follows:

13. Reinvestment Fee. Each time a Unit is transferred, the Association shall levy against the Unit a reinvestment fee of one-half percent (1/2%) of the sale price of the Unit to be deposited directly into the Association's reserve fund. The reinvestment fee shall be due and payable from the Unit's buyer on the date the deed transferring title to the Unit is recorded. The reinvestment fee is an assessment against the new Owner and an assessment and lien against the Unit and shall be collectible as such.
