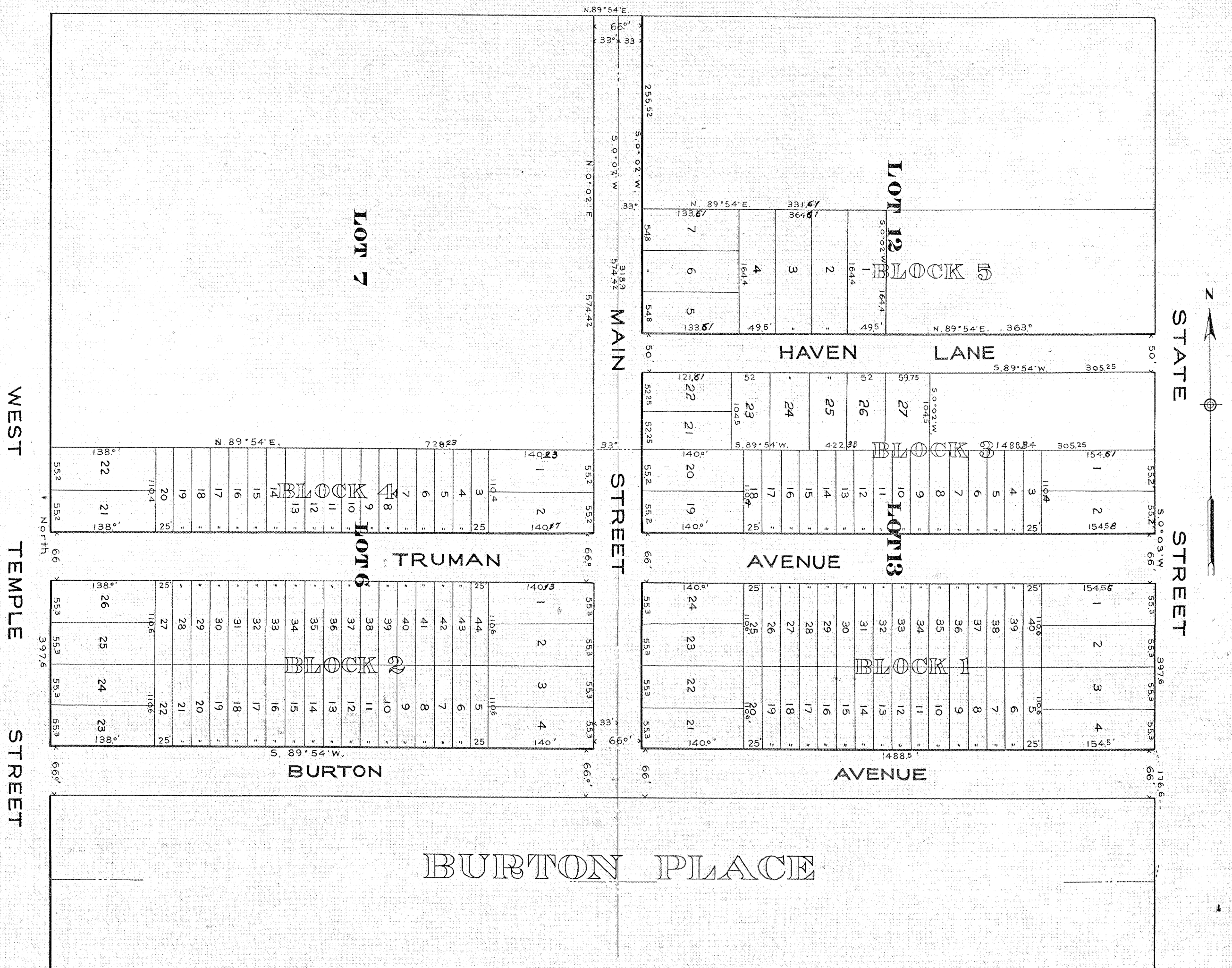


# BURTON PLACE PLAT "A"
