THIRD AMENDMENT TO DECLARATION OF CONDOMINIUM OF THE

BEN LOMOND SUITES CONDOMINIUM PROJECT

This THIRD AMENDMENT TO DECLARATION OF CONDOMINIUM OF THE BEN LOMOND SUITES CONDOMINIUM PROJECT (this "Third Amendment") is made effective and executed by the ACADIA NORTH, LLC, a Utah limited liability company ("Sole Owner").

RECITALS

- A. WHEREAS, Ben Lomond Suites Condominium Project is a condominium project located at 2510 Washington Boulevard, Ogden, Weber County, Utah as further described in Exhibit B attached hereto (the "Condominium Project");
- B. WHEREAS, the Declaration of Condominium governing the Condominium Project was recorded in the office of the Weber County Recorder, State of Utah, on September 14, 1984, as Entry No. 919072 in Book 1454 at Page 71 (the "Original Declaration");
- C. WHEREAS, the First Amendment to the Declaration of Condominium of the Ben Lomond Suites Condominium Project was recorded in the office of the Weber County Recorder on June 5, 1989, as Entry No. 1080393 in Book 1562 at Page 253 (the "First Amendment");
- D. WHEREAS, the Second Amendment to the Declaration of Condominium of the Ben Lomond Suites Condominium Project was recorded in the office of the Weber County Recorder on March 18, 2004, as Entry No. 2018449 (the "Second Amendment");
- E. WHEREAS, Sole Owner owns one hundred percent (100%) of the Units comprising the Condominium Project and, as such, holds one hundred percent (100%) of the voting rights of the Condominium Project, and, as such, is vested with the unilateral authority to adopt and record this Third Amendment against the Condominium Project;
- F. WHEREAS, the original Record of Survey Map for the Condominium Project was recorded in the office of the Weber County Recorder, State of Utah, on September 14, 1984, as Entry No. 919073 (the "Plat");
- G. WHEREAS, an "Amendment to Record of Survey Map of the Ben Lomond Suites Condominium Project Amended Basement Floor, Second Floor and Third Floor" was recorded in the office of the Weber County Recorder, State of Utah, on June 5, 1989, as Entry No. 1080394

(the "Amended Plat");

- H. WHEREAS, Sole Owner has resolved to amend the Plat and the Amended Plat to convert all three of the convertible units on the basement level of the Condominium Project, (i.e., Units 1A, 1B and 2 (the "Basement Convertible Units")), such that all of the floor area formerly comprising the Basement Convertible Units shall henceforth be reconfigured into a new Unit 4 of 2,874 square feet, designated for use as storage areas, and the remainder as Common Area; and
- I. WHEREAS, amendment of the Plat decreases the total aggregate floor area of the Units on the Condominium Project, and increases the total aggregate floor area of the Common Areas, and, as such, necessitates the recordation of this Third Amendment.

NOW, THEREFORE, the undersigned hereby submits this Third Amendment to the Original Declaration as follows:

AMENDMENT

- 1. <u>Defined Terms</u>. Capitalized terms used and not otherwise defined in this Third Amendment shall have the meaning or meanings given to them in the Declaration.
- 2. <u>Status of Recitals.</u> The Recitals set forth above shall constitute a portion of the terms of this Third Amendment.
- 3. Plat Amendment. All of the Convertible Spaces formerly designated as Units 1A, 1B, and 2, as the same were depicted in that certain Amended Basement Floor, Second Floor and Third Floor is hereby amended and as depicted on that certain "Ben Lomond Suites Condominium Project 3rd Amended" being recorded concurrently herewith in the office of the Weber County Recorder, as Entry No. ______ (the "Third Amended Plat"). The Unit Number of each new Unit which is being created from the Convertible Space is as shown on the Third Amended Plat. The size of the new Unit is as shown on the Third Amended Plat. After recordation of the Third Amended Plats, no Basement Convertible Units shall exist.
- 4. Revised Exhibit A to Declaration. Exhibit A to the Original Declaration, setting forth the percentage ownership interests of each Unit Owner in the Common Areas of the Condominium Project and the votes allocated to each Unit Owner is hereby stricken and replaced with Exhibit A attached hereto.
- 5. <u>Declaration and Bylaws Remain in Effect</u>. This Third Amendment shall be considered supplement to the Original Declaration. Except as expressly amended herein, the Original Declaration shall remain in full force and effect and shall not be cancelled, suspended or otherwise abrogated by the recording of this Third Amendment.
- 6. <u>Effective Date</u>. This Third Amendment shall be effective as of the date of its recordation in the official real property records of the Recorder in and for Weber County, Utah.


