HINTZE FAMILY PARTNER-SHIP, an easement for ingress and egress to their adjacent property, over, across, and through the City property described in Utah County, Utah, more particularly described as:

Commencing at a point which is offset northeastward 28.0 feet from the center of an existing dirt road and is North 632.02 feet and West 861.63 feet from the South quarter corner of Section 7, T6S, R3E, S.L.M.; thence 75.92 feet along the arc of a 104.0 foot radius curve concave northeastward (the central angle is 41 degrees 49'25"); thence North 83 degrees 24'00" East 4.06 feet; thence 108.04 feet along the arc of a 302.0 foot radius curve concave southward (the central angle is 20 degrees 29'50"); thence South 76 degrees 06'10" East 51.79 feet; thence 62.02 feet along the arc of a 151.0 foot radius curve concave southwestward (the central angle is 23 degrees 32'02"); thence 119.96 feet along the arc of an 81.0 foot radius curve concave northward (the central angle is 4 degrees 51'25"); thence South 47 degrees 25'33" east 56.00 feet to a point which is offset southeastward 28.0 feet from the center of an existing dirt road; thence 202.90 feet along the arc of a 137.0 foot radius curve concave northward (the central angle is 84 degrees 51'25"); thence 39.02 feet along the arc of a 95.0 foot radius curve concave southwestward (the central angle is 23 degrees 32'02"); thence 76 degrees 06'10" W 51.79 feet; thence 88.01 feet along the arc of a 46.0 foot radius curve concave southward (the central angle is 20 degrees 29'50"); thence South 83 degrees 24'00" West 34.06 feet; thence 116.79 feet along the arc of a 160.0 foot radius curve concave northeast (the central angle is 41 degrees 49'25"); thence North 35 degrees 13'25" East 56.0 feet to the point of beginning.

The basis of bearing is South 89 degrees 49'44" West along the section line from the south quarter corner as described above.
