Taylor Landing Phase 2 Temporary Storm drain-utility Easement

A temporary storm drain/utility easement located in part of the Northwest Quarter of Section 28, Township 6 North, Range 2 West of the Salt Lake Base and Meridian described as follows:

Commencing at the West Quarter Corner of Section 28, Township 6 North, Range 2 West of the Salt Lake Base and Meridian monumented with a Brass Cap; thence S 89°13'14" E 2224.08 feet along the south line of the Northwest Quarter of said Section 28; thence N00°46'08"E 1001.00 feet; thence N 89°13'14" W 698.71 feet along the north line of Boyd Russell Subdivision, 1st Amendment and Hazy Acres Subdivision;

thence N 00°46'10" E 132.54 feet to the Northwest Corner of Lot 39, Taylor Landing Phase 2; and the POINT OF BEGINNING and running

thence N 89°13'14" W 99.38 feet; thence N 00°42'56" E 56.04 feet; thence N 44°32'16" E 36.10 feet; thence N 00°42'56" E 113.89 feet;

- 2) thence S 24°26'56" E 36.48 feet to the point of beginning.
