

SUBDIVISION AGREEMENT  
AND  
COVENANT RUNNING WITH THE LAND  
(Red Ledges Recreational Community - Phase I)

THIS AGREEMENT entered into this 3 day of October, 2007, by and between Heber City, hereinafter referred to as "City" and the undersigned as "Developer".

WHEREAS, the petitioner has proposed the Red Ledges Recreational Community - Phase I, consisting of 203 single-family;  
NOW, THEREFORE, the parties hereby agree as follows:

1. With respect to the approved final subdivision plat, the Developer shall, prior to recordation of that subdivision plat, submit a letter from Twin Creeks Special Service District, "TCSSD", indicating that the Developer is in compliance with all water rights requirements for Phase 1, and obtain TCSSD signature on the plat indicating subdivision compliance with all TCSSD requirements;
2. With respect to the approved final Phase 1 subdivision plat, the Developer shall, prior to recordation of that subdivision plat, submit a letter from Central Utah Water Conservancy District, indicating their approval of all road crossings and facility impacts.
3. With respect to the approved final Phase 1 subdivision plat, the Developer shall, prior to work in any wetland areas, secure the necessary permit from the Army Corp approving the proposed wetland improvements. Upon completion of the improvements the subdivision will insure the wetlands remain in compliance with Army Corp requirements for the project.
4. The Developer shall comply with Chapter 18.102 of Heber City Code (the Affordable Housing Ordinance), through payment in-lieu to the Wasatch County Housing Authority. The Phase 1 requirement shall be calculated according to the Adopted Master plan for Red Ledges for the 203 units in Phase 1, and for Phase 1 totals \$240,961. Receipt of payment to the Housing Authority shall be provided to Heber City prior to plat recordation;
5. Required improvements of the development include construction and dedication of public trails within the Phase I development areas. All trails will conform to the standards defined by the Wasatch County Trails Standards, with the exception of limited sections of back county trails that may reach slopes up to 20 percent. Those public trails

to be constructed as part of Phase 1 are shown on the plat as dedicated public trails. Public trails will be maintained by Heber City.

The Developer shall also provide a detailed landscaping and fencing plan, to be installed as part of Phase 1 along the north side of Lake Creek Road;

6. The Developer shall provide and obtain Heber City approval on a Red Ledges Storm Water Management Plan prior to plat recordation. Plan will be consistent with Local, State, and Federal requirements for storm water. Plan shall address operation, maintenance, notifications, and public information efforts, etc. and have enforcement provisions.
7. The Developer shall construct all weather access improvements, as determined by the Fire District, from the existing turnaround on 1050 North in Wasatch View Acres, to and including, the emergency access gate located at the culdesac on the edge of the subdivision boundary, and other locations as shown in the construction drawings;
8. Acceptance of this subdivision is conditional upon offsite improvements. This subdivision will not be deemed complete until TCSSD has accepted the construction of all off-site water, sewer and reuse transmission lines and tanks required to provide adequate service to this development;
9. All lots on the final plat shall be prohibited from establishing driveway access from Lake Creek Road and the Bypass Road;
10. Lake Creek Road improvements shall be constructed to a minimum 42-foot wide asphalt road as approved by the City per the approved construction drawings. Heber City will reimburse the Developer for widening the road asphalt beyond 36-feet, excluding acceleration and deceleration lanes required for the project, from the west project boundary to 2400 East. Reimbursement will be payable upon final acceptance of the improvements by Heber City and upon receiving invoices demonstrating actual costs incurred by the Developer to install the improvements;
11. Homeowners Association. The Developer shall create a homeowners association ("RL HOA") which includes the following responsibilities:
  - a. Enforcement of Conditions and Restrictions ("CC&R's"), including the Red Ledges design guidelines.
  - b. Creation of a Red Ledges Architectural Review Committee (RLARC) which reviews all home designs for compliance

with the Red Ledges design guidelines. RLARC will work closely with the Heber City Planning Department to minimize impacts to the areas considered to be sensitive ridgeline lots. Based upon the collaborative effort between the City and the Developer, sensitive ridgeline areas located within Phase I have been identified and will be subject to the additional review terms and procedures as defined in the Architectural Review Committee protocol for the Project. The responsibility for review and enforcement is that of the RLARC, with the goal to balance the impacts to the landscape caused by disruption to the site (i.e. location of driveways and homes) and construction (i.e. height of homes) within these lots.

- c. Perpetual maintenance of all open space, private trails, private streets and sidewalks, and other facilities deeded to the RL HOA as identified on the final plat for Red Ledges ("Common Area")
  - d. Perpetual maintenance of all natural and street drainage facilities, including swales, ponds, berms, pipelines, boxes, etc. located within privately held roadways and common areas.
  - e. Monitoring and enforcing project compliance with the approved Red Ledges Storm Water Management Plan, and conducting a joint annual Storm Water Management Compliance Review with Heber City to review the status of storm water facilities and compliance with the plan.
  - f. Insuring compliance with Army Corp requirements related to wetlands on the property.
  - g. Collection of assessments from homeowners within Red Ledges for maintenance of the Common Area and RL HOA deeded property.
  - h. Establishing CC&R's, Bylaws, and Articles of Incorporation for the RL HOA of which the CC&R's shall be recorded with the Red Ledges phase one final plat.
  - i. Prohibiting fencing and grade changes on utility easements.
12. Developer will provide a copy of their noxious weed control plan approved by the Wasatch County Weed Control Board;
  13. All aforementioned improvements shall consist of frontage improvements of curbs, sidewalks (where required), pavements, inlets, landscaping and placing of monuments, as required and consistent with approved development standards;
  14. Said improvement costs will be paid by the Developer, their assigns, transferees or successors as owners or Developers. The Developer shall be obligated to disclose and

- notify in writing its immediate successors in ownership or Developers of the requirements of this Agreement;
15. Developer shall execute a performance agreement and provide a bond guaranteeing the improvements as required by the city engineer related to phase one (1);
  16. The parties agree that building permits shall not be issued prior to final acceptance of all required improvements or as required by City code;
  17. The Developer agrees to include the following at the time the Bypass Road portion of the project is approved:
    - a. Berming, landscaping, and irrigation infrastructure from Lake Creek Road to 1200 East, excepting any portions to be constructed by the Stone Creek Subdivision.
    - b. A temporary gravel parking area within the Public Park to be used for the temporary trailhead parking, off the Bypass Road. At such time that the public park located to the east of the Bypass Road is constructed, this temporary parking area will be replaced with the permanent parking and other related facilities.
  18. The Developer agrees to include the following at the time the Equestrian Parcel is approved:
    - a. Extension of the public trail along Lake Creek Road to the eastern boundary of the Property.
  19. In the event there is a Failure to Perform under this Agreement and it becomes reasonably necessary for any party to employ the services of an attorney in connection therewith (whether such attorney be in-house or outside counsel), either with or without litigation, on appeal or otherwise, the losing party to the controversy shall pay to the successful party reasonable attorney's fees incurred by such party and, in addition, such costs and expenses as are incurred in enforcing this Agreement;
  20. This Agreement contains the entire agreement between the parties, and no statement, promise or inducement made by either party hereto, or agent of either party hereto which is not contained in this written Agreement shall be valid or binding; and this Agreement may not be enlarged, modified or altered except in writing approved by the parties.
  21. Time is of the essence of this Agreement. In case any party shall fail to perform the obligations on its part at

the time fixed for the performance of such obligations by the terms of this Agreement, the other party or parties may pursue any and all remedies available in equity, at law, and/or pursuant to the terms of this Agreement.

22. This Agreement shall be a covenant running with the land, and shall be binding upon the parties and their assigns and successors in interest. This Agreement shall be recorded with the Wasatch County Recorder.

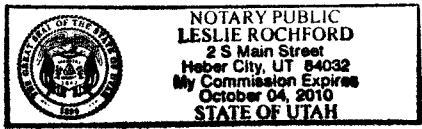
