AMENDMENT TO PROTECTIVE COVENANTS

WHEREAS, the undersigned and each of them are owners of Lots and parcels of real property situate in the South 1/4 of the Northeast Quarter, and the North 1/4 of the Southeast Quarter of Section 29, Township 2 North, Range 1 East, Salt Lake Base and Meridian, and

WHEREAS, on the 18th day of October, 1954 owners of real property within the area described above, executed certain "Protective Covenants" concerning the use of said real property, which document was duly recorded in the office of the Davis County Recorder, on October 22, 1954 in Book 73, Page 60 of Official Records, Entry No. 140813, and

WHEREAS, said "Protective Covenants" provide in part as follows:

"1. LAND USE AND BUILDING TYPE. No lot shall be used except for residential purposes..."

and

WHEREAS, it is necessary and desirable that such provision be amended, Now Therefore,

IT IS AGREED between the undersigned owners of real property and Lots within the areas described above that Paragraph 1. be amended and shall hereafter read as follows:

1. LAND USE AND BUILDING TYPE. No lot shall be used except for residential purposes. Provided, however, that a church building or buildings may be located and constructed on any Lot or Lots or real property not subdivided.

Except as amended above, said "Protective Covenants" remain in full force and effect and unaffected hereby.

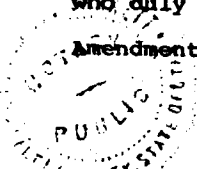
