THIS ASSIGNMENT AND ASSUMPTION OF DECLARANT'S RIGHTS UNDER THE DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS FOR SKY RANCH ("Assignment"), dated as of April 19, 2024, by and between CW Land Co., LLC, a Utah limited liability company ("Assignor"), Scott R. Brusseau, an individual, and Lisa Brusseau, and individual (collectively "Assignee").

RECITALS:

WHEREAS, Assignor is the owner of the real property located in Weber County, State of Utah, more particularly described as Lot 3 of the Sky Ranch Subdivision plat recorded in Book 93, pages 27-28 of the official real estate records of Weber County Recorder, Utah on June 14, 2022, as Instrument #3241023, together with the building, structures and other improvements located thereon.

WHEREAS, by that certain Purchase and Sale Agreement dated as of March 28, 2024, as amended, (the "Purchase Agreement"), between Assignor, Sky Ranch Partners, LLC, and Assignee, Assignor has agreed to sell, transfer and assign to Assignee its rights, title, and interests as the Declarant, including, without limitation, all Special Declarant Rights, under the Declaration of Covenants, Conditions, and Restrictions for Sky Ranch, recorded 4/19/24, in the office of the Weber County Recorder as Document No. 3322471, (the "Declaration").

WHEREAS, Assignee wishes to acquire all of Assignor's right, title and interest (i) as the Declarant under the Declaration, including, without limitation, all Special Declarant Rights and assume Assignor's duties and obligations related thereto from and after the date of this Assignment.

NOW, THEREFORE, in consideration of the promises and the mutual agreements herein contained and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

AGREEMENT:

1. Definitions. Unless otherwise defined herein, all capitalized terms shall have the meaning as set forth in the Declaration.
2. Assignment and Assumption. Effective as of the date first stated above, Assignor hereby sells, transfers, conveys, assigns and sets over to Assignee all rights, title, and interests of Assignor as the Declarant in and under the Declaration, including, without limitation, all Special Declarant Rights and Assignee hereby assumes all the duties, obligations, and liabilities of Assignor thereunder from and after the date of this Assignment.
3. Governing Law. This Assignment shall be governed by and construed under the laws of the State of Utah without giving effect to the principles of conflict of laws thereof.
4. Counterparts. This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which taken together shall constitute one and the same agreement.

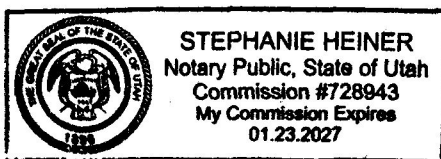


