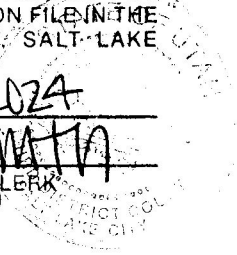

2. Defendants Brenda Tuinei and Atom Transport LLC are not infants or incompetent persons;

3. Defendants Brenda Tuinei and Atom Transport LLC have been personally served pursuant to Rule 4(d)(1); and

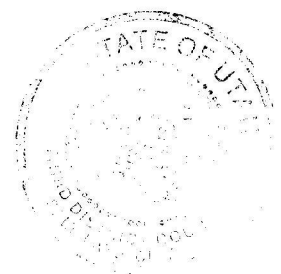
4. The claim against Defendants Brenda Tuinei and Atom Transport LLC is for a sum that can be made certain by computation, plus interest, to wit:
