

August 22, 1991 AMENDMENT TO THE
DECLARATION OF CONDOMINIUM
OF
THREE FOUNTAINS - PROVO

Section 25. Transfer or Lease of Units is hereby amended by adding the following:

In order (a) to protect the equity of the individual property Owners at Three Fountains - Provo, (b) to carry out the purpose for which the Condominium was formed by preserving the character of the Condominium as a homogeneous residential community of predominantly owner-occupied Units and by preventing the Condominium from assuming the character of an apartment, renter-occupied complex; and (c) to comply with the eligibility requirements for financing in the secondary mortgage market insofar as such criteria provide that the project be substantially owner-occupied, leasing of a Unit or Units shall be prohibited, except in the case of undue hardship as provided below.

(a) The Management Committee shall be empowered, upon written application, to allow reasonable leasing of Units to avoid undue hardship on an Owner. By way of illustration and not by limitations, examples of circumstances which would constitute undue hardship are those in which (i) an Owner must relocate his or her residence and cannot, within ninety (90) days from the date the Unit was placed on the market, sell the Unit while offering it for sale at a reasonable price no greater than its current appraised market value; (ii) the Owner dies and the Unit is being administered by his or her estate; (iii) the Owner takes a leave of absence or temporarily relocates and intends to return to reside in the Unit; (iv) the Unit is to be leased to a member of the Owner's immediate family, which shall be deemed to encompass children, grandchildren, grandparents, brothers, sisters, parents, and spouses. Those Owners who have demonstrated that the inability to lease their Unit would result in undue hardship and have obtained the approval of the Management Committee may lease their Units for such duration as the Management Committee reasonably determines is necessary to prevent undue hardship.

Any Owner who believes that he or she must lease his or her Unit to avoid undue hardship shall submit a written application to the Management Committee setting forth the circumstances necessitating the leasing, a copy of the proposed lease, and such other information as the Management Committee may reasonably require. Leasing in the case of undue hardship shall be permitted only upon the Management Committee's written approval of the Owner's application. When a lease is approved, a copy of the lease, signed by the lessee and lessor, shall be submitted to the Management Committee within ten (10) days after it has been signed by both parties.

The Management Committee shall have the power to adopt and enforce reasonable rules and regulations and to assess fines, in accordance with the Declaration and By-Laws, in order to enforce the provisions of this subparagraph. Any transaction which does not comply with this Section shall be voidable at the option of the Management Committee.

Any violation of the Declaration, By-Laws, or rules or regulations adopted pursuant thereto by any lessee is deemed to be a violation of the terms of any lease and authorizes the unit owner to terminate the lease without liability and to evict the Lessee in accordance with the laws of the State of Utah. Each unit owner hereby delegates and assigns to the Association, acting through the Management Committee, the power and authority to evict a Lessee on behalf of and for the benefit of the unit owner, in accordance with the terms hereof. In the event the Association proceeds to evict the Lessee, any costs, including attorney's fees and court costs associated with the eviction, shall be specially assessed against the unit and the unit owner thereof, such being deemed hereby as an expense which benefits the leased unit and the unit owner thereof.
