Beginning on the south boundary line of the Grantors' land at the southwest corner of College Park Acres, a non-regular subdivision in Block 2, Irving Park Addition, and running thence N.89°58'19" E. 129.5 feet, along said south boundary line, thence N. 0°03'34" W. 116 feet, thence S.89°58'19" W. 62.5 feet, thence S.0°03'34" E. 7 feet, thence N.89°58'19" E., 55.5 feet, more or less, thence S.0°03'34" E. 104 feet, more or less, thence S.89°58'19" W. 122.5 feet, thence S.0°03'34" E. 5 feet to the point of beginning, and being in Lots 25 and 26 of said College Park Acres Subdivision, a non-regular subdivision, in Block 2, Irving Park Addition. southwest corner of College Park Acres, a non-regular subdivision
