of Salt Lake County, State of Utah, Grantors, do hereby convey and warrant to the TAYLORSVILLE-BENNION IMPROVEMENT DISTRICT, Salt Lake County, Utah, organized and existing under and by virtue of the laws of the State of Utah, Grantee, a right of way and easement for the purpose of digging a trench along said right of way, and to lay, maintain, operate, repair, remove or replace main pipe line for transportation through and across the Grantors' land and premises in Salt Lake County, State of Utah. The right of way and easement herein granted is located in: Norwest 1/4 of Northwest 1/4 Section 17, Township 2 South, Range 1 West, Salt Lake Base and Meridian

the center line of said/main pipe shall extend through and across the above land and premises on a line described approximately as follows: Beg. at a point which is N 89°54'30" West 7.0 ft. from the NW Corner of Lot 8, Westwood No. 1 Sub., said point also being N 0° 05'29" West along the section line 1,549.90 ft. and East 997.45 ft. from the W 1/4 Cor. Sec. 17, T2S, R1W, SLB&M, and running thence North 29.6 ft., thence N 89°54'30" West 733.7 ft., thence N 0°02'29" East 217.0 ft. Also beg. at a point N 0°05'29" West along the sec. line 1,614.09 ft. and East 312.55 ft. from the W 1/4 Cor. of Sec. 17, T2S, R1W, SLB&M, and running thence So. 33 ft.

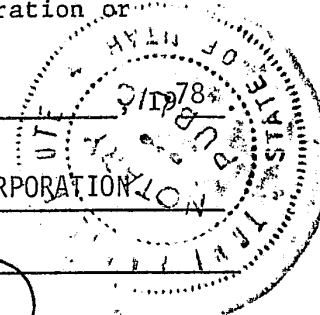
TO HAVE AND TO HOLD the same unto the TAY-BEN IMP. DIST. so long as such main pipe line shall be maintained, with the right of ingress and egress to and from said right of way, and to maintain, operate, repair and remove or replace the same. The said Grantor to fully use the said premises for the purposes for which this right of way or easement is granted to the said Grantee.

The rights hereby granted are subject to the condition that Grantee shall compensate Grantor at a reasonable appraised valuation for any damages done to Grantors' land or crops caused by Grantee in the construction, maintenance, repair and operation or replacement of said main pipe line.
