- **6.10 Recreational Vehicles.** This amendment is to prohibit and/or restrict the activities of recreational vehicles such as motorbikes, snowmobiles, dune buggies, etc. or other commercial/playground projects as inappropriate uses not conducive to the quiet, rural horse community as 'intended' in the development of the properties.
- 2. Except as amended by the provisions of the First, Second and Third Amendments to Declaration, the Declaration shall remain unchanged and shall constitute the entire Declaration of Protective Easements, Covenants, Conditions and Restrictions for the Development.
