Syracuse City, a municipal corporation of the State of Utah, Grantor, County of Davis, State of Utah, hereby RELEASES AND RELINQUISHES to The United States of America and its assigns, Grantee, acting pursuant to the provisions of the Act of June 17, 1902 (32 Stat. 388) and acts amendatory thereof or supplementary thereto, particularly the Reclamation Project Act of 1939, (53 Stat. 1197), for the sum of One (\$1.00) Dollar, and other good and valuable considerations, all rights, title and interest granted to Syracuse City in and to those certain Easements executed the 30th day of May, 1996, by Blackburn Jones Real Estate Inc.; said Easements were recorded as Entry No. 1256460 in Book No. 2013 at Page No. 1061 in the Office of the Davis County Recorder, Utah; said Easements are over and upon the following described parcel of land in Davis County, State of Utah, to-wit:

A part of the above referenced Easements, being part of an entire tract of property, situate in Lot 33 and Lot 34, Stone Haven Subdivision Phase 3, according to the official plat thereof, recorded June 18, 1996 as Entry No. 1256460 in Book 2013 at Page 1061, situate in the NE1/4 SE1/4 of Section 8, Township 4 North, Range 2 West, Salt Lake Base and Meridian. The boundaries of said parcel of land are described as follows:

Beginning at the Northwest corner of said Lot 34; and running thence along the northerly and easterly boundary lines of said Lots 34 and 33 the following three (3) courses

and distances: (1) S.89°45'18"E. 75.00 feet to a point of curvature of a curve to the right with a radius of 25.00 feet; (2) thence southeasterly along said curve with an arc length of 39.27 feet, chord bears S.44°45'18"E. 35.36 feet; (3) thence S.00°14'42"W. 176.47 feet to the Southeast corner of said Lot 33; thence N.26°09'11"W. 22.49 feet; thence N.00°14'42"E. 156.32 feet to a point of curvature of a curve to the left with a radius of 15.00 feet; thence northwesterly along said curve with an arc length of 23.56 feet, chord bears N.44°45'18"W. 21.21 feet; thence N.89°45'18"W. 65.00 feet; thence S.00°14'42"W. 10.15 feet; thence N.26°09'11"W. 22.49 feet to the point of beginning as shown on the official map of said project on file in the office of the Utah Department of Transportation.
