
NOTICE OF RELINQUISHMENT

The Declaration pertains to the "Property" located in Davis County, Utah, which is described on Exhibit "A" attached hereto.

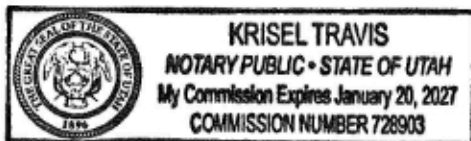
