#### NOTICE OF REINVESTMENT FEE COVENANT

The duration of the above referenced Reinvestment Fee Covenant shall continue and remain in full force and effect until there is recorded an instrument directing the termination or amendment of such Reinvestment Fee Covenant, as provided in the Association's governing documents.

As of the date of this Reinvestment Fee Covenant, a one-time reinvestment fee shall be paid to the Association when a change in ownership or transfer of a Lot occurs in the amount of one-half of one percent (0.005) of the sales price of the Lot, unless a lesser amount is established by Board of Directors from time to time. 
