AMENDMENT TO RIGHT-OF-WAY and EASEMENT CONTRACT

RECITALS:

- A. Whereas, by that certain Right-of-Way Contract dated 4/25/90, "The Contract", Land Number 317, recorded in the records of Utah County, Book 2684, Page 439, John Norton Jacob, as Grantor, granted and conveyed unto Grantee a right-of-way on, over and through certain real property situated in Utah County, State of Utah, as described and identified in the Contract.
 - B. Whereas, the undersigned Grantor warrants that it is now the owner in fee simple of the following described property:

Beginning at the center of Section 6 Township 6 South, Range 1 West, Salt Lake Base and Meridian; Thence North 00° 13' 45" East 529.79 feet; Thence south 89 00° 46' 15" East 532.19 feet to the West Right-of-Way line of Lake Mountain Road; Thence along said Right-of-Way the following three courses: South 12° 27' 58" East 278.94 feet, Southeasterly along the arc of a 572.00 foot radius curve to the right 190.81 feet, the chord bears South 02° 54' 34" East 189.93 feet, South 06° 38' 50" West 71.01feet; Thence North 89° 31' 35" West 595.96 feet to the center of said Section 6, and the point of beginning.

AGREEMENT:

NOW THEREFORE, for and in consideration of the mutual promises contained in this Amendment, Grantor grants to Grantee an amendment as described below:

 The parties desire and agree to amend the Contract to allow construction of an additional pipeline and appurtenances. The additional pipeline will be located approximately 25-feet from the existing pipeline and the right-of-way configuration will be 25-feet from the edge of the right-of-way to each pipeline and 25-feet between pipelines. The total width of the right-of-way easement for the pipelines is 75feet.
