SUPPLEMENT TO THE DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS FOR MT. SARATOGA VILLAGES 3 & 5 COMMON ASSOCIATION

This Supplement to the Declaration of Covenants, Conditions, and Restrictions for Mt. Saratoga Villages 3 & 5 Common Association ("Supplemental Declaration") is executed and adopted by Edge Homes Utah, LLC, a Utah limited liability company ("Declarant").

RECITALS

- A. This Supplemental Declaration shall modify and supplement the *Declaration of Covenants, Conditions, and Restrictions for Mt. Saratoga Villages 3 & 5 Common Association* recorded with the Utah County Recorder's Office on August 2, 2022, as Entry No. 86672:2022, and any amendments or supplements thereto (the "Sub-Master Declaration").
- B. Edge Homes Utah, LLC is the Declarant (by assignment/transfer) and is the owner of the real property subject to this Supplemental Declaration. Edge Homes Utah, LLC hereby consents to subjecting the Subject Property (defined below) to the terms, covenants and restrictions contained herein and those terms, covenants and restrictions contained in the Sub-Master Declaration.
- C. Under the terms of the Sub-Master Declaration, Declarant reserved the right to expand the Mt. Saratoga Villages 3 & 5 neighborhood by the addition of all or a portion of the Additional Land described in the Sub-Master Declaration. Declarant desires to add a portion of the Additional Land as hereinafter provided.
- D. This Supplemental Declaration shall provide notice to the Owners of Lots (condominium units) within the property identified on <u>Exhibit A</u> attached hereto, that all of such Lots/units are subject to the Sub-Master Declaration, and all Owners of Lots within such property are and shall be members of the Sub-Master Association (defined below).
- E. Unless otherwise defined herein, capitalized terms shall have the same meaning as defined in the Sub-Master Declaration.

ANNEXATION

NOW THEREFORE, in consideration of the recitals set forth above, the Declarant hereby declares and certifies as follows:

- 1. Annexation of Additional Land. Declarant hereby confirms that all of the real property identified on Exhibit A attached hereto, together with (i) all buildings, improvements, and structures situated on or comprising a part of the above-described real property, whether now existing or hereafter constructed; (ii) all easements, rights-of-way, and other appurtenances and rights incident to, appurtenant to, or accompanying said real property; and (iii) all articles of personal property intended for use in connection therewith (collectively referred to herein as the "Subject Property") is submitted to and properly annexed into the Sub-Master Declaration and made part of the Mt. Saratoga Villages 3 & 5 Common Association neighborhood.
- 2. <u>Subdivision Plat</u>. The real property described in Paragraph 1, and the improvements to be constructed thereon, all of which are submitted to the terms and conditions of the Sub-Master

Declaration, are more particularly set forth on the condominium plats (15 condominium buildings, each containing 10 condominium units) that have been or will be recorded in the office of the Utah County Recorder against the real property described in <u>Exhibit A</u> hereto.

- 3. <u>Submission</u>. The Subject Property shall hereinafter be held, transferred, sold, conveyed, and occupied subject to the covenants, restrictions, easements, charges, and liens set forth in the Sub-Master Declaration and all supplements and amendments thereto, as well as the other written covenants recorded against the Subject Property.
- 4. <u>Sub-Master Association Membership</u>. The Owner of each Lot (condominium unit) within the Subject Property shall be a member of the Mt. Saratoga Villages 3 & 5 Common Association (the "Sub-Master Association"), and shall be entitled to all benefits of such membership and shall be subject to the terms governing the Sub-Master Association as set forth in the Sub-Master Declaration and Bylaws. Voting in the Sub-Master Association and assessment allocations shall be apportioned among the Lots/units within the Subject Property in accordance with the Sub-Master Declaration.
- 5. Reservation of Declarant's Rights. Pursuant to the Sub-Master Declaration, all rights concerning the Project reserved to Declarant in the Sub-Master Declaration are hereby incorporated and reserved to Declarant with respect to the Subject Property. The exercise of Declarant's rights concerning such Subject Property shall be governed by the terms, provisions and limitations set forth in the Sub-Master Declaration.
- 6. <u>Effective Date</u>. This Supplemental Declaration shall take effect upon being recorded with the Utah County Recorder.
