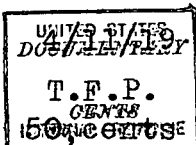

WHEREAS, a Certificate of the Register of the Land Office at Salt Lake City, Utah, has been deposited in the General Land Office, whereby, it appears, that pursuant to the Act of

Congress of May 20, 1862, "To Secure Homesteads to Actual Settlers on the Public Domain", and the acts supplemental thereto, the claim of Leroy E. Lott has been established and duly consummated, in conformity to law, for the southwest quarter of Section thirty-four in Township Five south of Range one west of the Salt Lake Meridian, Utah, containing one hundred sixty acres, according to the Official Plat of the Survey of the said Land, returned to the GENERAL LAND OFFICE by the Surveyor-General:

NOW KNOW YE, That there is, therefore, granted by the UNITED STATES unto the said claimant the tract of land above described; TO HAVE AND TO HOLD the said tract of Land, with the appurtenances thereof, unto the said claimant and to the heirs and assigns of the said claimant forever; subject to any vested and accrued water rights for mining, agricultural, manufacturing, or other purposes, and rights to ditches and reservoirs used in connection with such water rights, as may be recognized and acknowledged by the local customs, laws, and decisions of courts; and there is reserved from the lands hereby granted, a right of way for ditches or canals constructed by the authority of the United States.

IN TESTIMONY WHEREOF, I Woodrow Wilson President of the United States of America, have caused these Letters to be made Patent, and the seal of the General Land Office to be hereunto affixed.

GIVEN under my hand, at the City of Washington, the NINTH day of OCTOBER in the year of our Lord one thousand nine hundred and EIGHTEEN and of the Independence of the United States the one hundred and FORTY-THIRD.

NOW THEREFORE, I WILLIAM SPRY, GOVERNOR, in consideration of the premises, and by virtue of the power and authority vested in my by the laws of the State of Utah, in such case made and provided do issue this PATENT, in the name and by the authority of the State of Utah, hereby granting and confirming unto the said ZENOS W. TIFFANY and to his heirs and assigns forever, the following piece or parcel of land situate in the County of UTAH State aforesaid, to-wit:

The East Half (E- $\frac{1}{2}$ ) of the North West quarter (NW- $\frac{1}{4}$ ) and the East Half (E- $\frac{1}{2}$ ) of the South West quarter (SW- $\frac{1}{4}$ ) of Section Seventeen (17) in Township Nine (9) South Range Three (3) East of the Salt Lake Meridian, containing One Hundred Sixty (160) acres according to the said certificate

TO HAVE AND TO HOLD the above described and granted premises unto the said ZENOS
