AMENDED AND RESTATED NONEXCLUSIVE EASEMENT

Grantee shall be obligated to repair, replant or recondition the property subject to the easement to its original condition following any entrance upon such property by Grantee. This easement shall continue in perpetuity unless terminated by Grantee's execution and recordation of a Notice of Termination. The terms and provisions of this easement shall be binding upon and inure to the benefit of the successors and assigns of the Grantor and Grantee.
