# AMENDMENT TO DECLARATION OF BUILDING AND USE RESTRICTIONS

THAT WHEREAS, a majority of the present owners of lots located in the Briarcreek Estates Subdivision, Phase II, according to the official plat thereof recorded in the office of the County Recorder of Salt Lake County, State of Utah, have petitioned the Granite School District, developers of said property, for a change in the Declaration of Building and Use Restrictions. The following Amendment is hereby accepted:

## PART B. 6 is amended to read:

b. Dwellings shall be located so as to maintain side yards totaling not less than 20 feet to adjacent lot lines, however, no dwelling shall be located nearer than 8 feet on one side of the structure to any interior lot line except that a 1 foot side yard shall be permitted for a garage or other permitted accessory building located 40 feet or more from the front building setback line. No main building shall be located on any interior lot nearer than 15 feet to the rear lot line. Detached garages or other permitted accessary buildings may be located within 7 feet of the rear lot line so long as such buildings do not encroach upon any easements.
