Addendum Number 1 To Tuhaye Development Agreement

This Addendum Number 1 to the Tuhaye Development Agreement ("Addendum") is entered into this 17 day of 2012, by and between Tuhaye LLC, a Utah limited liability company ("Tuhaye") and Wasatch County, a political subdivision of the State of Utah ("County"). Tuhaye and the County are sometimes collectively referred to as the "Parties". This Addendum is to supplement and modify the Tuhaye Development agreement executed by Tuhaye and the County on May 15, 2003 and recorded at the Wasatch County Recorder on June 4, 2003 as Entry No. 258692, Book 0628, Pages 0438-0512 (the "Development Agreement").

RECITALS

- A. This Addendum is intended by the parties hereto to be an addendum to the Development Agreement.
- B. The County, acting pursuant to authority delegated to it under the laws of the State of Utah, and in furtherance of its land use policies, goals, and objectives, ordinances, and regulations, in the exercise of its discretion has elected to approve and enter into this Addendum, modifying and supplementing the Development Agreement.
- C. The Developer engaged Alpine Trails, Inc. to construct trails within the Project (defined below). Due to a requirement related to trails and a trailhead as part of the original approvals for the Project, the Parties wish to enter into this Addendum to memorialize the requirements and timing of the items described herein.
- D. Definitions: Any term or phrase used in this Addendum that has its first letter capitalized shall have that meaning given to it in this section:
 - 1) "County" shall mean Wasatch County and shall include, unless otherwise provided, any and all of the County's agencies, departments, officials, employees or agents.
 - 2) "Developer" shall mean Tuhaye.
 - 3) "Project" shall mean the Property and the development on the Property which is the subject of this Addendum, including all phases or plats regularly approved by the County and any ancillary and additional improvements or endeavors incident to the development of the Project.

4) "Home Owners Association" shall mean the Tuhaye Home Owners Association.

Now, therefore, in consideration of the mutual promises, covenants, and provisions set forth herein, the receipt and adequacy of which are hereby acknowledged, the Parties agree as follows:

AGREEMENT

- 1. Construction of the North-South Trail Along the West End of the Project, and the East-West Trail Along the North End of the Project.
 - 1.1. **Property Affected**. The Property that is subject to the provisions of this Addendum is shown generally on Exhibit A.
 - 1.2. <u>Trail Construction</u>. Developer has constructed public trails consisting of a north/south trail along the west end of the Project as well as an east/west trail along the north end of the Project, both as shown on Exhibit B attached hereto (the "Trails"). The Trails have been constructed to the Wasatch County Standards for Backcountry Trails as defined in Chapter 16.38, Appendix 3, Wasatch County Trail Standards and Design Guidelines.
 - 1.3. <u>Trail Maintenance</u>. The Developer shall maintain the Trails in all respects until turned over to the Home Owners Association, after which the Home Owners Association shall maintain the Trails in all respects. Developer understands that all the Trails are to tie into a countywide public trail system and connections to Public Trails on adjacent properties will be allowed.
 - 1.4. <u>Trail Easement</u>. Tuhaye shall record a Public Trail Easement Agreement in the form of Exhibit "C" attached hereto. The alignment of the Trails may be adjusted from time-to-time as provided under Paragraph 8 of that Easement Agreement. If the Trail adjustment is not within the Public Trail Easement, the easement shall be amended.
 - 1.5. <u>Trail Signage</u>. The Trails shall be signed at the intersections of the public/private streets and trails consistent with the signage of the existing trail intersections within the Project and as shown on Exhibit D.

2. Installation of a Trailhead.

2.1. Location. As part of the master plan approvals for the Project, the Developer is required to coordinate with the west side property owners on the location, development, and construction of a trailhead. The location of the Trailhead will be finalized by the time installation of the Trailhead is to occur, as provided in Section 2.3 below. A potential trailhead location is depicted on Exhibit E attached hereto, but the actual location finalized through said

process may be elsewhere, whether within or outside Developer-owned property. Developer understands that the construction of the Trailhead will be done in a timely manner soon after the conditions in Section 2.3 are met.

- 2.2. <u>Improvements to the Trailhead</u>. When installed, the trailhead shall include a hard surface area (which does not have to be asphalt), a kiosk (similar to the depiction on Exhibit F attached hereto) for a trail map printed on coreplast or product of similar durability, and wheelstops.
- 2.3. <u>Timing and Maintenance of Trailhead</u>. The County intends that the two Trails will become part of a larger Countywide trail system. The trailhead shall be installed when the Trails become connected to a functioning Countywide "public trail system", and the trailhead shall be maintained by the Developer until turned over to the Home Owners Association (if it is located on Developer-owned property).
- 2.4. Adjustments. Developer shall have the right to adjust or alter the location of the trailhead from time-to-time as necessary to accommodate the development of or improvements to any property owned or controlled by the Developer or any affiliate or related party. Any relocation of the Trailhead will be subject to County approval so that the utility of the Trailhead is not materially compromised.

3. Updated Notice Parties and Addresses.

3.1. The Parties and addresses for notice purposes under Section 12 of the Development Agreement are hereby updated and revised as follows:

4. Successors and Assigns of Developer.

4.1. This Addendum shall be binding on the successors and assigns of Developer, and assignment of the same shall be governed by the applicable provisions in the Development Agreement.

5. Recordation of This Addendum to the Development Agreement.

5.1. No later than ten (10) days after the Parties enter into this Addendum, the County Clerk shall cause to be recorded, at Developer's expense, an executed copy of this Addendum in the Official Records of the County of Wasatch.

6. Covenants to Run With the Property.

6.1. The provisions of this Addendum shall constitute real covenants, contract and property rights, and equitable servitudes, which shall run with all of the land subject to this Addendum, and the County shall have all the rights and remedies contained in the Development Agreement to ensure performance of these obligations.

7. Incorporation of Recitals and Introductory Paragraph.

7.1. The Recitals contained in this Addendum, and the introductory paragraph preceding the Recitals, are hereby incorporated into this Addendum as if fully set forth herein.





PUBLIC TRAIL EASEMENT AGREEMENT

This Public Trail Easement Agreement ("Agreement") is made and entered into as of the date of last execution below by and between Tuhaye LLC, a Utah limited liability company, Tuhaye ELM Inc., a Delaware Corporation, Tuhaye West, Inc. (formerly, Ameagle PC Holdings, Inc.), a Delaware corporation (collectively "Owner"), the State of Utah, acting by and through the Director of the School and Institutional Trust Lands Administration ("SITLA"), and Wasatch County, a Utah political subdivision ("County"). Owner, SITLA and the County are collectively referred to as the "Parties".

WHEREAS, Owner and SITLA are the owners of real property generally referred to geographically as Tuhaye located in Wasatch County, Utah ("Property"); and

WEREAS, County desires, and Owner has constructed, a public recreation trail across the Property, as more particularly described on Exhibit A; and

WHEREAS, the Parties have expressly relied upon the provisions and protections of Utah Code Chapter 14, Title 57 (also referred to as the Utah Limitation of Landowner Liability-Public Recreation Act) in agreeing to grant public trail access over a portion of the Property.

Now therefore, in consideration of Ten Dollars (\$10.00) and the mutual covenants and agreements hereof, the sufficiency and receipt of which are hereby acknowledged, the Parties agree as follows:

1. Owner and SITLA grant to the County, for public use in accordance with this grant, and the Property is hereby burdened by, a perpetual non-exclusive easement for the sole purpose of creating and maintaining a public recreation trail ("Trail") over a portion of the Property, more particularly described on Exhibit A attached hereto.

- 2. The Parties intend and agree that the use of the Trail shall be for a "Recreational purpose" as defined in Section 57-14-2 of the Utah Code Annotated, and for a "Recreational activity" as defined in Section 78B-4-509 of the Utah Code (also referred to as the "Recreation Land Use Immunity Act").
- 3. Nothing herein shall constitute the County's waiver of any portion of the Governmental Immunity Act of Utah, the Utah Limitation of Landowner Liability-Public Recreation Act, the Recreation Land Use Immunity Act, or any defense arising thereunder or therefrom.
- 4. Nothing herein shall constitute the Owner's or SITLA"s waiver of any portion of the Utah Limitation of Landowner Liability-Public Recreation Act, the Recreation Land Use Immunity Act, or any defense arising thereunder or therefrom.
- 5. To the extent permitted by the Utah Constitution and the Governmental Immunity Act of Utah, the Utah Limitation of Landowner Liability Public Recreation Act, and the Recreation Land Use Immunity Act, the County shall, within the limits of the Utah Governmental Immunity Act, defend and indemnify Owner and SITLA against any liability for damage to life or property arising from the public use of the easement under this Agreement.
- 6. The maintenance of the trail shall be done consistent with Section 3.1(b)(9) of the Development Agreement between Owner and County dated May 15, 2003 and recorded at the Wasatch County Recorder on June 4, 2003 as Entry No. 258692, Book 0628, Pages 0438-0512.
- 7. No motorized vehicles shall be allowed to use the Trail except for maintenance or emergency use by the County or those authorized by Owner (including, without limitation, road, street or golf cart path crossings).
- 8. Owner shall have the right to adjust the alignment of the Trail from time-to-time as necessary to accommodate development of or improvements to any property owned or controlled by Owner or any affiliate or related party, and any such adjustment shall be memorialized by an amendment to this Agreement executed and recorded by Owner.


