QUIT-CLAIM DEED

Guild and Mabel Guild, his wife, and Hugh H. Erekson and Julia Margaret Erekson, his wife, all of Kansas; and William Myrick and Martha H. Myrick, his wife, and Hugh Evans and Fannie Evans, his wife, all of Marion; and all of Summit county, state of Utah; and Julia F. Smith, of Minneapolis, Minnesota, grantors, hereby quit-claim to Summit County, a municipal corporation of the state of Utah, grantee, for the sum of one dollar and other valuable consideration, all of their right, title and interest in and to the following described tract of land in Summit county, state of Utah:
