MYTON CITY, UTAH ORDINANCE NO. 021408

AN ORDINANCE VACATING A PORTION OF A PUBLIC STREET KNOWN AS 200 NORTH IN MYTON CITY, UTAH

WHEREAS, the City Council of Myton City, Utah, has the authority, on its own initiative or by petition, pursuant to Utah Code §10-9a-609.5, to vacate public streets and right of way within Myton City; and

WHEREAS, the City has complied with the public notice requirements of Utah Code sections § 10-9a-208;

WHEREAS, on the 8^{TH} DAY OF FEBRUARY, 2007, the City held a public hearing according to the law, concerning the proposed vacation of a portion of 200 NORTH, as described herein; and

WHEREAS, the City Council has found that there is good cause to vacate the street right of way and that the vacating of the street right of way will not be detrimental to the public interest.

NOW, THEREFORE, be it ordained by the Governing Body of Myton City, Utah that:

1. The public street right of way for a portion of 200 NORTH, as shown on the attached Exhibit "A" is hereby vacated and pursuant to Utah Code section §10-9a-609.5(3), the City does hereby revoke any acceptance of the dedication of such street right of way and does hereby relinquish its fee interest, if any, to the property. The private rights of way and easements therein, if any, of any lot owner and the franchise rights of any public utility shall not be impaired by this action.
