DEED FOR EASEMENT

THIS INDENTURE, made this 291975, between UNION PACIFIC LAND RESOURCES CORPORATION, a corporation of the State of Utah, Grantor and NORTH SALT LAKE, a municipal corporation of the State of Utah, Grantee,

## WITNESSETH:

That said Grantor, for good and valuable consideration, the receipt whereof is hereby acknowledged, hereby grants and conveys unto said Grantee, its successors and assigns, a perpetual easement for the purpose of constructing, reconstructing, installing, operating, maintaining and repairing an underground storm sewer pipeline on, over or across the following described property in North Salt Lake, Davis County, Utah to wit:

A parcel of land situate in the West Half of the Northeast Quarter (W\*NE\*L) of Section 11, Township 1 North, Range 1 West, Salt Lake Base and Meridian, in the City of North Salt Lake, Davis County, State of Utah, bounded and described as follows:

Commencing at the intersection of the easterly right-of-way line of the Oregon Short Line Railroad Company and the northwesterly noaccess line of Highway known as Project No. 15-7, said point being 50.0 feet distant easterly, measured at right angles from the center line of the easterly or westbound main track of said Railroad at Railroad Survey Station 1666+61.9, said station being 275.6 feet north from the south line of the NE% of said Section 11, measured along said center line of the westbound main track;

thence N. 46° 16' E., a distance of 509.64 feet to a point 397.57 feet distant easterly measured at right angles from said center line of the westbound main track at Railroad Survey Station 1662+89.17.

thence N. 18° 43' E., a distance of 510.77 feet to a point 533.61 feet distant easterly measured at right angles from said center line of the westbound main track at Railroad Survey Station 1657+96.85;

thence N. 4° 30' E., a distance of 245.99 feet to a point 538.56 feet distant easterly measured radially from said center line of the westbound main track at Railroad Survey Station 1655+44.4;

thence N. 0° 04' W., a distance of 1271.72 feet to a point on the southerly right-of-way line of Cudahy Lane and the westerly no-access line of said project, said point being 305.5 feet distant easterly measured at right angles from the center line of said westbound main track at Railroad Survey Station 1642+07.07;

thence N. 89° 18' W., a distance of 204.72 feet along said southerly right-of-way line of Cudahy Lane to the TRUE POINT OF BEGINNING;

thence continuing N. 89° 18' W., along said southerly right-of-way line, a distance of 56.92 feet, more or less, to a point on the easterly right-of-way line of said Railroad, said point being 50.0 feet distant easterly measured at right angles from said center line of the westbound main track at Railroad Survey Station 1642+70.12;

thence southerly, along said easterly right-of-way line of said Railroad, a distance of 25.34 feet;
