## RIGHT OF WAY AGREEMENT FOR

of Salt Lake County, State of Utah, grantor, do hereby convey and warrant
to the Salt Lake City Suburban Sanitary District #1, Salt Lake County,
State of Utah, grantee, a right-of-way easement for the purpose of
digging a trench along said right-of-way, to lay, maintain, operate,
repair, remove or replace a pipeline for transportation through and
under the grantors' land and premises in Salt Lake County, State of
Utah.

The easement herein granted is 10 feet wide lying 5 feet on each side of any sanitary sewer line which lies within the following described property and which serves more than one building.

Beginning at the Southwest corner of Lot 2, Block 13, Ten Acre Plat "A", Big Field Survey, located in Section 36, Township 1 South, Range 1 West, Salt Lake Base and Meridian and running thence North 0°02'50" West 922.35 feet; thence South 89°56'40" East 187.92 feet; thence South 0°15'47" East 5.10 feet; thence South 89°56'40" East 180.91 feet; thence South 0°14'47" East 917.40 feet; thence North 89°54'15" West 372.04 feet to the point of beginning.

TO HAVE AND TO HOLD the same unto the SALT LAKE CITY SUBURBAN SANITARY DISTRICT #1 so long as such pipeline shall be used and maintained, with the right of ingress and egress to and from said right-of-way, and to maintain, operate repair and remove or replace the same. The grantor shall not build thereon any permanent structure or building, nor plant large trees whose root zones would contact or interfere with the pipeline. The easement may, however, be crossed or covered with sidewalks, curb and gutter, roadways, driveways, fences or similar improvements.

THE GRANTEE HEREBY AGREES to compensate grantor the reasonable appraised value for any damages done to grantors' land or crops caused by grantee in the construction, maintenance, repair, operation or replacement of said line or appurtenant facilities.
