Detailed Explanation (Required): This plat was recorded with 821 N as the street name. This is not a valid street grid coordinate. A more appropriate grid coordinate would have been 990 N. The street sign at the intersection of Pine Canyon and Meadow Creek Lane has both 821 North and Meadow Creek Lane on it with equal sized lettering. The sign at the intersection of Meadow Creek Way and Meadow Creek Lane has no grid coordinate on it, just Meadow Creek Lane. This document is an attempt to make the mapping system, tax system, and signs match, hopefully removing any future confusion.
