Absent:

After the meeting had been duly called to order and other matters not pertinent to this resolution had been discussed, a Certificate of Compliance with Open Meeting Law with respect to this April 1, 1993 meeting was presented to the City Council, a copy of which is attached hereto as Exhibit "A".

Thereupon in accordance with the motion duly made, seconded, and carried at the meeting of the City Council on March 18, 1993, the original Notice of Intention with respect to the St. George, Utah Special Improvement District No. 93-1 as modified be approved and confirmed by the City Council at its March 18, 1993 meeting, was presented to the City Council for final review.

The City Council then determined that, after taking into account the modifications made to the original Notice of Intention, there were insufficient protests filed by the owners of the property to be assessed to defeat the creation of the District, and Councilmember Jones then introduced the following resolution in writing, which was fully discussed and moved its adoption:

A RESOLUTION TO CREATE THE ST. GEORGE, UTAH SPECIAL IMPROVEMENT DISTRICT NO. 93-1 DESCRIBED IN THE NOTICE OF INTENTION CONCERNING THE DISTRICT, AS MODIFIED; AUTHORIZING THE CITY OFFICIALS TO PROCEED TO MAKE IMPROVEMENTS AS SET FORTH IN THE NOTICE OF INTENTION TO CREATE THE DISTRICT, AS MODIFIED; AND RELATED MATTERS.

BE IT RESOLVED by the City Council of the City of St. George, Washington County, Utah:

Section 1. The City Council of the City of St. George, Washington County, Utah (the "City"), hereby determines that it will be in the best interest of the City to construct certain improvements within the City. The specific description of the nature of the improvements is more particularly set out in the Notice of Intention which has been published and mailed as required by law, and which has been subsequently amended as follows:

NOTICE OF INTENTION

PUBLIC NOTICE IS HEREBY GIVEN that on the 4th day of February, 1993, the City Council of the City of St. George, Washington County, Utah (the "City"), adopted a resolution declaring its intention to create a special improvement district to be known as St. George, Utah Special Improvement District No. 93-1 (the "District"). It is the intention of the City Council to make improvements within the District and to levy special assessments as provided in Title 17A, Chapter 3, Part 3, Utah Code Annotated 1953, as amended, on the real estate lying within the District for the benefit of which such assessments are to be expended in the making of such improvements.

DESCRIPTION OF DISTRICT

The boundaries of the proposed District shall include the following property within the city limits:

INTENDED IMPROVEMENTS

The improvements to be constructed within the District include a sewage collection system (including mains, laterals, manholes, and related improvements), roadway construction and drainage, curb and gutter, sidewalk, street lighting, the purchase, condemnation, or other acquisition of any property necessary to make such improvements, and all other miscellaneous work necessary to complete the work in a proper workmanlike manner.

Said improvements will be constructed along all streets within the boundaries of the proposed District where required.

ESTIMATED COST OF IMPROVEMENTS

The total cost of improvements in the District as estimated by the Public Works Director is \$2,300,000, which shall be paid by a special assessment to be levied against the property affected or specifically benefited by such improvements. The City Council has determined to offset a portion of the costs with a contribution of \$100,000 since the improvements contemplated within the District will alleviate a health hazard that the City Council believes should be presently addressed. In addition, should the City determine to upgrade the sewage collection system, any additional costs incurred as a result of said upgrading will be paid by the City in the amount of approximately \$50,000. The total estimated cost of the improvements may be financed during the construction period by the use of interim warrants, in which case the interest on said warrants will be assessed to the property owners. The estimated cost to be assessed against the properties within the District and the method of assessment shall be as follows:

Sidewalk: This item is optional and will be installed at the property owner's request. The property owner shall be responsible for removing and/or relocating private improvements as required. If the property owner desires to have the City remove said private improvements, the City will include the cost of removal in the assessment to be levied against the benefited property.	\$10		Per Front Foot

The above estimated assessment rates include a 15% charge for overhead costs of the city. Should the city determine to issue bonds prior to the completion of the improvements within the District, 10% of the construction costs may be added to the assessments to cover construction contingencies. Where assessments are on a per lot basis, all north area lots will be assessed equally and all south area lots will be assessed equally, regardless of the number of lots used to build a home. Property owners will be responsible to pay the cost of hooking onto the sewage collection system from their home to their property line as well as sewer impact fees and monthly service charges as provided by City ordinance.

Property owners shall be responsible for all costs associated with restoring private yard improvements, including, but not limited to, regrading to fit new roadway elevations, relandscaping, rebuilding of walls and fences, etc. The District shall pay for removal of any improvements within the public right-of-way and removal and replacement of driveways to fit new roadway elevations.

¹The North Area is that area north of Main of Ward Road and the South Area is that area south of Main of Ward Road within the District boundaries.

²Lots include parcels of land that qualify as a lot under the City zoning ordinance. For homes built on multiple lots, the first lot upon which the residence is built shall pay 100% of the assessment and any additional lots rendered unusable due to encroachment of the residence shall pay 50% of the assessment levied against said lots.

Any property owners needing assistance in calculating their proposed assessments hereunder may obtain assistance in the City Engineer's office during regular working hours.

LEVY OF ASSESSMENTS

It is the intention of the City Council to levy assessments as provided by the laws of Utah on all parcels and lots of real property to be benefited by the proposed improvements within the District. The purpose of the assessment and levy is to pay those costs of the improvements which the City will not assume and pay. The method of assessment shall be by lineal front foot or by lot as set forth herein.

The assessments may be paid by property owners in not more than ten (10) annual installments with interest on the unpaid balance at a rate or rates fixed by the City Council, or the whole or any part of the assessment may be paid without interest within fifteen (15) days after the ordinance levying the assessment becomes effective. The assessments shall be levied according to the benefits to be derived by each property within the District. Other payment provisions and enforcement remedies shall be in accordance with Title 17A, Chapter 3, Part 3, Utah Code Annotated 1953, as amended.

A map of the proposed District, copies of plans, profiles and specifications of the proposed improvements and other related information are on file in the office of the City Engineer who will make such information available to all interested persons.

TIME FOR FILING PROTESTS

Any person who is the owner of record of property to be assessed in the District described in this Notice of Intention shall have the right to file in writing a protest against the creation of the District or to make any other objections relating thereto. Protests shall describe or otherwise identify the property owned of record by the person or persons making the protest and shall indicate the total front footage and/or number of lots represented by said protest. Protests shall be filed with the City Recorder of the City of St. George, Utah, on or before 5:00 p.m. on the 15th day of March, 1993. Thereafter at 5:00 p.m. on the 18th day of March, 1993, the City Council will meet in public meeting at the offices of the City Council to consider all protests so filed and hear all objections relating to the proposed District.

After such consideration and determination, the City Council shall adopt a resolution either abandoning the District or creating the District either as described in this Notice of Intention or with deletions and changes made as authorized by law; but the City Council shall abandon the District and not create the same if the necessary number of protests as provided herein have been filed on or before the time specified in this

Notice of Intention for the filing of protests after eliminating from such filed protests: (i) protests relating to property or relating to a type of improvement which has been deleted from the District and (ii) protests which have been withdrawn in writing prior to the conclusion of the hearing. The necessary number of protests shall mean the aggregate of the following:

(a) Protests representing one-half of the front footage of property to be assessed in cases where an assessment is proposed to be made according to frontage; and

(b) Protests representing one-half of the lots to be assessed in cases where an assessment is proposed to be made according to lot.

Section 2. The City Council has heretofore considered each and every protest filed and has heard each and every person who wished to be heard in protest against the creation of the District or making of any of the improvements therein or on any other matter pertinent to the District.

Section 3. The improvements proposed and described in the Notice of Intention to create the District, as modified, are hereby authorized and the District is hereby created.

Section 4. The City Council reasonably expects to reimburse from proceeds of debt to be incurred by the City Council, capital expenditures advanced by the City for the installation and construction of the improvements herein described in a principal amount of approximately \$2,300,000. This expectation constitutes a declaration of official intent of the City Council pursuant to Treasury Regulation §1.103-18(f)(1).

Section 5. The properties to be included in the District described in the original Notice of Intention, as modified, are hereby approved by the Council. The legal description and tax identification number of said properties are more fully set forth on Exhibit "B" attached hereto.

Section 6. As required by law, the City Recorder is hereby authorized and directed to file a copy of the Notice of Intention and resolution creating the District as finally approved, together with a list of properties proposed to be assessed described by tax identification number and legal description, in the Washington County Recorder's office within five days from the date hereof.
