ORDINANCE NO. 984

DATE Dec 17, 1986

AN ORDINANCE CHANGING THE NAMES OF LOMMOND WAY, 3780 SOUTH, 3785 SOUTH AND 3720 SOUTH WITHIN THE PERIMETERS OF THE FOLLOWING TEN NAMED SUBDIVISIONS IN SALT LAKE COUNTY:

Heather Heights #1
Upland Terrace Plat B
Upland Terrace Plat F
Maple Hills Subdivision
Delmar Subdivision

Heather Heights #2
Upland Terrace Plat C
Bon View Subdivision
Upland Terrace Plat A
Upland Terrace Plat E Amended

The Board of County Commissioners of the County of Salt Lake ordains as follows:

Section I. That the name of four public streets within the perimeters of the following ten named subdivisions in Salt Lake County, Utah:

Heather Heights #1
Upland Terrace Plat B
Upland Terrace Plat F
Maple Hills Subdivision
Delmar Subdivision

Heather Heights #2
Upland Terrace Plat C
Bon View Subdivision
Upland Terrace Plat A
Upland Terrace Plat E Amended

which are presently designated as Lommond Way, 3780 South, 3785 South and 3720 South be and the same are hereby changed to Upland Drive.

SECTION II. (1) The Board of County Commissioners finds and is satisfied that the name change is necessary to avoid confusion and to maintain continuity in the designation of public streets in recorded subdivisions in Salt Lake County, that said name change has also been approved by the Development Services Division and the County Address Coordinator, that such name change will not be detrimental to the general public interest, that neither the public nor any person will be

materially injured thereby, and, that such name change should be made.

(2) The Salt Lake County Recorder shall record this ordinance and make the necessary change on the official plats and records of the County to effectuate the purpose hereof.

SECTION III. This ordinance shall become effective fifteen (15) days after its passage and upon at least one publication in a newspaper published and having general circulation in Salt Lake County.
