POLE LINE EASEMENT

THE STATE OF UTAH, through and by its State Land Board by its duly appointed, qualified and acting Executive Secretary, Grantor, of Salt Lake City, in the County of Salt Lake, State of Utah, hereby grants to UTAH POWER & LIGHT COMPANY, a Corporation, its successors in interest and assigns, Grantee, for the sum of One Dollar (\$1.00) and other valuable consideration, a perpetual easement and right of way for the erection and continued maintenance, repair, alteration and replacement of the electric transmission, distribution and telephone circuits of the Grantee, and two guy anchors and twenty poles with the necessary guys, stubs, crossarms and other attachments thereon, or affixed thereto, for the support of said circuits, to be erected and maintained upon and across the premises of the Grantor in Utah County, Utah, along a center line described as follows:

Beginning on the quarter section line of Section 22, T. 6 S., R. 1 W., S.L.M., at a point 2350 feet east, more or less, from the west quarter corner of said Section 22, thence S. 2° 00' W. 898 feet, more or less, thence S. 12° 06' W. 1930 feet on said land and being in the E 1/2 of the SW 1/4 of said Section 22, and the NE 1/4 of the NW 1/4 of Section 27, Township and Range aforesaid.

Also, beginning on the north line of Section 11, T. 6 S., R. 1 W., S.L.M., at a point 177 feet west, more or less, from the north quarter corner of said Section 11, thence S. 29° 43' W. 3030 feet, more or less, to the south boundary line of Grantor's land and being in the E 1/2 of the NW 1/4 and Lot 1 of said Section 11.
