# FIRST AMENDMENT TO THE AMENDED AND RESTATED MASTER DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS FOR GARDNER POINT

This First Amendment to the Amended and Restated Master Declaration of Covenants, Conditions, and Restrictions for Gardner Point ("First Amendment") is executed and adopted by Edge Gardner Point, LLC, a Utah limited liability company ("Declarant").

### **RECITALS**

- A. The Amended and Restated Master Declaration of Covenants, Conditions, and Restrictions for Gardner Point was recorded on May 3, 2022 as Entry No. 55030:2022 in the office of the Utah County Recorder ("**Declaration**").
- B. This First Amendment affects the real property located in Utah County, described with particularity on Exhibit A, which exhibit is attached hereto and incorporated herein by reference.
- C. The Association desires to amend the Declaration as set forth in this First Amendment to modify rental regulations within the Project.
- D. Unless otherwise set forth herein, the capitalized terms shall have their same meanings and definitions as stated in the Declaration.
- E. Pursuant to Article XIV, Section 14.1 of the Declaration, the undersigned hereby certifies that this First Amendment was approved by the Declarant pursuant to its unilateral amendment power.
- F. As of the date of the recording of this First Amendment, the Control Period remains in effect.

#### <u>AMENDMENT</u>

- **NOW, THEREFORE**, in consideration of the foregoing Recitals, the Declarant hereby executes this First Amendment, which shall be effective as of its recording date with the Utah County Recorder.
- (1) <u>Amendment No. 1</u>. The fourth sentence in Article XI, Section 11.9 shall be deleted in its entirety and replaced by the following:

"Unless otherwise modified by Association Rule, no Owner shall be permitted

to lease their Dwelling for transient, hotel, or seasonal purposes; all leases shall be for an initial term of no less than six (6) consecutive months; and no Owner may lease individual rooms to separate persons or less than their entire Dwelling unless the Owner also lives in the Dwelling as their primary residence."

- (2) <u>Conflicts</u>. All provisions of the Declaration not specifically amended in this First Amendment shall remain in full force and effect. In the case of any conflict between the provisions of this document and the provisions of the Declaration or any prior amendments, the provisions of this document shall in all respects govern and control.
- (3) <u>Incorporation and Supplementation of Declaration</u>. This document is supplemental to the Declaration, which by reference is made a part hereof, and all the terms, definitions, covenants, conditions, restrictions, and provisions thereof, unless specifically modified herein, are to apply to this document and are made a part hereof as though they were expressly rewritten, incorporated, and included herein.
