Said part of an entire tract is described as the Northerly 15 ft. of said Lot 4, containing 0.03 acre.

By granting this easement, Grantor is restricted from excavating, drilling or piledriving below a depth of 15 ft. within the boundaries of said described part of an entire tract without written permission from Grantee.
